WHEREAS, recognition was granted u/s14 & 15(1) of NCTE Act, 1993 to the institution namely, St. Ignatius College of Education, Palayamkottai-627002, TamilNadu run by I.C.M Educational Society, No. 06 Crawford, Madurai, TamilNadu for B.Ed., B.Ed.-A.I. & M.Ed. Programme as per following details:-

- (i) Order No. F.TN/B.Ed/20/SRO/NCTE/2000-2001/783 dated 06.07.2000 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2001-2002.
- (ii) Order No. F.SRO/NCTE/B.Ed.-AI/2009/12065 dated 28.04.2009 for conducting B.Ed.-AI Course of one year duration with an annual intake of 100 students from the academic session 2009-2010.
- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 30.05.2015 for B.Ed., B.Ed.-Al & M.Ed. Programme and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 30.05.2015 and 29.06.2015 respectively for conducting B.Ed. & B.Ed.-Al Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16
- 3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 26.03.2019. The institution submitted reply of Show Cause Notice on 01.05.2019.
- 4. AND WHEREAS, the SRC in its 405th meeting held on 13th 14th December 2021 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 03.01. 2022. The institution did not submit any reply to the Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 421st Meeting of SRC held on 10th February 2023 considered the matter and Committee decided to withdraw the recognition. Accordingly, as per the decision of SRC, a withdrawal Order No. F.SRC/NCTE/AOS00443/B.Ed./TN/2023/141255-141259&F.SRC/NCTE/APS08729/B.Ed.-Al/TN/2023/141255-141259 was issued to the institution on 21.02.2023.

- **6. AND WHEREAS,** aggrieved by the Withdrawal order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-66/E-298101/2023 Appeal/5thMeeting, 2023 Appeal No.APPLSRC202314579 dated 22.05.2023 appeal remand back the order appealed against. The institution has submitted a reply to the Appeal Remand Back on 19.06.2023.
- 7. AND WHEREAS, the SRC in its 426th meeting held on 23rd June 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution St. Ignatius College of Education, Survey No. 1660/1, 1661, 1077, 1652, 1653, 1660/2, 1663/3, 1664/2, 1663/1, 1663/1, Palayamkottai District-627002, TamilNadu for B.Ed. programme 4 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. St. Ignatius College of Education, Survey No. 1660/1, 1661, 1077, 1652, 1653, 1660/2, 1663/3, 1664/2, 1663/1, 1663/1, Palayamkottai District-627002, TamilNadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (4 basic unit) of 50 students each subject to fulfilment of the following conditions:-
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 11.  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
