CONTINUATION ORDER

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Rayalaseema College of Physical Education, Rayavaram, Mydukur Road, Proddatur-516362, Kadapa District, Andhra Pradesh run by Rayalaseema College of Physical Education, Rayavaram, Mydukur Road, Proddatur-516362, Kadapa District, Andhra Pradesh vide order No. F.AP/NEW/M.P.Ed./SRO/NCTE/2003-2004/8735 dated 18.08.2003 for conducting M.P.Ed. Programme of one-year duration with an annual intake of 30 students from the academic session 2003-2004.

2. AND WHEREAS, a letter dated 16.02.2023 has submitted by the institution for the closure of M.P.Ed. Course.

3. AND WHEREAS, the SRC in its 422nd meeting held on 02nd – 03rd March 2023 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRC/NCTE/APS00557/M.P.Ed./AP/2023/141476-141480 was issued to the institution on 21.03.2023.

4. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-89/E-303634/2023 Appeal/6th Meeting, 2023 Appeal No.APPLSRC202314601 dated 12.06.2023 appeal remand back the order appealed against. The operative part of appeal order as under: -

“After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to SRC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the SRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The SRC is at liberty to verify the submitted documents from the concerned issuing authority”.

5. AND WHEREAS, the institution has submitted a reply on 20.06.2023, as per direction of appeal order.

6. AND WHEREAS, the SRC in its 426th meeting held on 23rd June 2023 considered the matter and decided as under:-

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Rayalaseema College of Physical Education, Survey No. 248/5, 246/2, 245/6, 242/4 & 249 of Kotha Pally Panchayat and Survey No. 111/1 and 148 of Thallamapuram Panchayath Proddatur Mandal, Kadapa District-516362, Andhra Pradesh for M.P.Ed. programme 1 basic unit of 40 students”.

7. NOW THEREFORE, this order is issued permitting the institution i.e. Rayalaseema College of Physical Education, Survey No. 248/5, 246/2, 245/6, 242/4 & 249 of Kotha Pally Panchayat and Survey No. 111/1 and 148 of Thallamapuram Panchayath Proddatur Mandal, Kadapa District-516362, Andhra Pradesh for continuation of recognition for M.P.Ed. Programme for two-years duration with an annual intake of 1 basic unit of 40 students subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:



- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.


13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
