CONTINUATION ORDER

WHEREAS, the recognition u/s. 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sana College of Education, Shantiniketan, Bhairidevarakoppa, P.B. Road, Hubli-580025, Dharwad District, Karnataka run by Sana Educational Charitable Trust, Hubli, Karnataka vide order No. F. SRO/NCTE/B.Ed./2005-2006/4824 dated 21.12.2005 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 28.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 10.12.2019. The institution vide letter dated 04.12.2019 submitted its reply for First Show Cause Notice.

4. AND WHEREAS, the SRC in its 389th Meeting held on 12th to 14th October 2020 considered the matter and committee decided to issue Final Show Cause Notice. As per uploaded decision on the website the institution has submitted reply of Final Show Cause Notice on dt. 04.11.2020.

5. AND WHEREAS, the SRC in its 401st meeting held on 11th -12th August, 2021 considered the matter and decided to withdraw the recognition. Accordingly, Withdrawal order was issued to the institution vide No. F.SRO/NCTE/APS01730 /B.Ed./KA/2021/128362 dated 24.08.2021.

6. AND WHEREAS, the institution has submitted Court Order on 18.10.2021 (Page- 601-610). The operative part is reproduced below:-

"The writ petition is, therefore, disposed of by directing the respondents to permit the petitioner to participate in counseling and admit students for the academic year 2021-22, and communicate the same to the petitioner's affiliating university and the concerned State Government authorities within one week.

The writ petition, alongwith the pending application, stands disposed of."

7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-256/E-198040/2021 Appeal/4th Meeting, 2022 APPLSRC202114112 dated 26.05.2022 reject the instant appeal and confirm the withdrawal order issued by SRC.

8. **AND WHEREAS**, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No. 9685/2022 titled as Sana College of Education versus NCTE & Anr. Whereby the Hon'ble High Court has directed that: -

"It is also to be seen that in terms of the interim order, the petitioner Institution has already admitted the students for the academic session 2021-22. This court under the facts of the present case, is inclined to set aside the impugned order and the appellate order with liberty to the SRC to re-inspect the petitioner Institution and to pass a fresh order. If petitioner Institution fulfills all requirements in accordance with the applicable NCTE Regulations, needless to state that the appropriate order in that respect can be issued. If the petitioner Institution is still lacking with the requirement, as stipulated under the applicable Regulations, an appropriate decision in that respect shall also be taken after giving opportunity of hearing to the petitioner Institution.

14. The petition stands disposed of alongwith pending application in the aforesaid terms.

9. **AND WHEREAS**, the SRC in its 421st meeting held on 10th February 2023 considered the matter and decided to constitute VT under section 13 of NCTE Act. Accordingly, as per the decision of SRC, a letter was issued to the Inspection Division, NCTE Hqrs on 27.02.2023. The institution vide dated 20.04.2023 has submitted a reply to the Letter for Online VT/Inspection.

10. **AND WHEREAS**, the online VT constituted dated 29.05.2023 with three members inspection committee i.e., Prof. J.R. Sonwane, Dr. Dilip Kumar Singh and Prof. Debashis Sanyal and was received on 30.05.2023.

11. **AND WHEREAS**, the SRC in its 426th meeting held on 23 June 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sana College of Education, Survey No. 366/1, 366/2, 1 to 9 Ward No. 24, Corporation Hubballi, Shantiniketan, Bhairidevarakoppa, P.B. Road, Hubballi-580025, Dharwad District, Karnataka for B.Ed. programme 2 basic units of 50 students each."



12. **NOW THEREFORE**, this order is issued permitting the institution i.e. Sana College of Education, Survey No. 366/1, 366/2, 1 to 9 Ward No. 24, Corporation Hubballi, Shantiniketan, Bhairidevarakoppa, P.B. Road, Hubballi-580025, Dharwad District, Karnataka for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

13. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

14. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;



- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

17. The institution shall make available the list of students admitted on its official website.


18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.


