**CONTINUATION ORDER**

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely **UK College of Education, Godumakunta, Keesara Mandal, Rangareddy District - 501301 Andhra Pradesh (Now Telangana)** vide order No. F.SRO/NCTE/B.Ed/2006-2007/2185 dated 01.05.2007 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) 50 students each from the academic session 2015-16.

3. **AND WHEREAS**, the inspection was conducted on 08.10.2016 and VT report received on 28.10.2016.

4. **AND WHEREAS**, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> October & 01<sup>st</sup> November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, a First Show Cause Notice was issued on 25.11.2019. The institution has submitted reply of show cause notice on 17.12.2019.

5. **AND WHEREAS**, the SRC in its 410<sup>th</sup> meeting held on 25<sup>th</sup> – 26<sup>th</sup> April, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 12.05.2022. The institution has submitted reply final show cause notice received on 15.06.2022.

6. **AND WHEREAS**, the SRC in its 412<sup>th</sup> meeting held on 05<sup>th</sup> – 06<sup>th</sup> July, 2022 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRC/NCTE/APS05740/B.Ed./TS/2022/132904-132908 dated 25.07.2022 was issued to the institution.

7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-235/E-273262/2022 Appeal/9<sup>th</sup> Meeting, 2022 dated 30.11.2022 appeal remand back the order appealed against. The institution has submitted reply of appeal remand back case received on 07.12.2022.

8. **AND WHEREAS**, the SRC in its 418<sup>th</sup> meeting held on 16<sup>th</sup> December, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 06.01.2023. The institution has submitted

reply final show cause notice received on 26.12.2022 as per uploaded decision on website of the minutes of SRC.

9. **AND WHEREAS**, the SRC in its 419<sup>th</sup> meeting held on 13<sup>th</sup> January, 2023 has considered the matter and decided to issue a letter to the Registrar, Osmania University. The institution vide email dt. 23.06.2023 has submitted a letter dt. 26.05.2023 issued by the Registrar, Osmania University, Hyderabad, Telangana.

10. **AND WHEREAS**, the SRC in its 426<sup>th</sup> meeting held on 23<sup>rd</sup> June, 2023 considered the matter and Committee decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -*

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution UK College of Education, Survey No. 32, Godumakunta Village, Keesara Mandal, Medchal-Malkajgiri District, Rangreddy District (old), Telangana – 501301 for B.Ed. programme for 2 basic units of 50 students each.*

11. **NOW THEREFORE**, this order is issued permitting the institution i.e. **UK College of Education, Survey No. 32, Godumakunta Village, Keesara Mandal, Medchal-Malkajgiri District, Rangreddy District (old), Telangana – 501301** for continuation of recognition for **B.Ed. Programme** for two years duration with an annual intake of **(2 basic units) of 50 students each** subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

13. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the



programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.


15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

16. The institution shall make available the list of students admitted on its official website.

17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.


