WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution **Basaveshwara College of Education, Sri Tontadarya Vidyapeeth, Gadag, Karnataka-582101** run by **Shree Jagadguru Tontadarya Vidyapeeth, Gadag, Karnataka** vide SRC vide order no. F.SRO/NCTE/B.Ed./2004-2005/8826 dt. 30.11.2004 for conducting **Secondary(B.Ed.)** course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 28.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units of 50 students** each from the academic session 2015-16.

3. **AND WHEREAS**, the institution has submitted a request for one unit of 50 students. The SRC in its 321st Meeting held on 28th to 30th September 2016 has considered the matter and decided to issue a letter. Accordingly, as per decision of SRC a letter was issued to the institution on 17.10.2016.

4. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019. The Committee decided to issue Show Cause Notice to all such institutions, which have not submitted compliance of the Revised Recognition order. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 30.10.2019. Thereafter, the institution has not submitted reply to Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 381st meeting held on 31st October to 01st November 2019 and 387th meeting held on 24th & 25th August 2020 has considered the matter and decided to issue Final Show Cause Notice to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 07.09.2020. Thereafter, the institution has submitted vide letter dt. 25.09.2020 reply to the Final Show Cause Notice.

6. **AND WHEREAS**, the SRC in its 400th Meeting held on 13th & 14th July 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 25.09.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution has not submitted notarized copy of LUC issued by the competent authority.
2. The institution has submitted attested copy of NEC in regional language. The institution has not submitted notarized copy of English version of NEC issued by the competent authority.
3. The institution has submitted building plan in which the seal is in regional language, hence issuing authority is not clear. Total site area and multipurpose hall area are not legible.
4. The institution has submitted attested copy of BCC which is not in the prescribed NCTE format. Total built up area and date of inspection are not mentioned in BCC.
5. The institution has submitted Form 'A' issued by the bank manager. 2 out of 3 FDRs are matured. The institution is required to submit Form "A" issued by the bank manager towards creation of FDR of Rs. 7 Lakhs & Rs. 5 Lakhs towards Endowment Fund & Reserve Fund.
6. The institute did not submit proforma of faculty approved by the University.
7. The institute submitted a copy of letter dated 20.07.2019 issued by the Registrar, Gulbarga University whereby only 14 Faculty is approved which is not sufficient for running B.Ed. course with 2 units as per NCTE Regulations.

Hence, the Committee decided to **withdraw the recognition** granted to **Basaveshwara College of Education, Sri Tontadaya Vidyapeeth, Gadag, Karnataka-582101** for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Basaveshwara College of Education, Sri Tontadarya Vidyapeeth, Gadag, Karnataka-582101** run by **Shree Jagadguru Tontadarya Vidyapeeth, Gadag, Karnataka** for conducting B.Ed. programme of two years duration with an annual intake of **100** students (2 basic units) w.e.f. the next academic session i.e., 2021-2022 onwards.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to

education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
