WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, St. Peter's Training College, Kolencherry P.O., Ernakulam District – 682311, Kerala vide order no. F.KL/SEC/N/327/SRO/NCTE/2004-2005/790 dated 23.02.2005 for conducting Secondary course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388^{th} meeting held on $14^{th}-15^{th}$ September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 13.10.2020. The institution has not submitted reply to the Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 419th Meeting held on 13th January, 2023 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 17.02.2023. The institution has submitted its reply vide letter dated 03.03.2023.
- **5. AND WHEREAS,** the SRC in its 423rd Meeting held on 12th April, 2023 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 03.03.2023. The Committee perused the reply submitted by the institution and found the following deficiencies.

- 1. The institution submitted a building plan for St. Peter & St. Paul Orthodox Syrian Church, which is used by St. Peters High School & Corporate. As per the building plan the built up area is 1756.14 sq. mt. which is not sufficient as per NCTE Regulations, 2014.
- 2. The building plan submitted by the institution not approved by Competent authority. The Building Completion Certificate BCS submitted by the institution not approved by Competent authority.

3. The institution has submitted photocopy of faculty staff list without mentioning of date of approval. As per the faculty list submitted the institution has not appointed faculty for Fine Art/Performing Arts and Physical Education.

Hence the recognition granted St. Peters Training College, Kolencherry, P.O, Ernakulam District – 682311, Kerala for B.Ed. programme is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws the recognition granted to *St. Peters Training College, Kolencherry, P.O, Ernakulam District 682311, Kerala* for conducting **B.Ed. programme** of two years duration with an annual intake of (1 basic unit) 50 students. No fresh admissions are permitted now onwards. However, if any student is pursuing **B.Ed. programme** is allowed to continue till they complete the course.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(7. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार वा अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
