WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Institute of Advanced Study in Education, Kakatiya University, Warangal-506009, Andhra Pradesh (Now Telangana) for conducting B.Ed Course of one year duration with an intake of 100 students vide order No. 42-102/2000 Appeal/8032 dated 01.02.2001.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit dated 19.01.2015 for its willingness of annual intake of 100 students in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in its 369th meeting held on 28.01.2019 has considered the matter and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 01.03.2019. The institution has submitted its reply vide letter dated 24.04.2019.
- **4. AND WHEREAS**, the SRC in its 378th meeting held on 25th 26th July, 2019 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 05.08.2019. The institution has submitted its reply vide letter dated 04.09.2019.
- 5. AND WHEREAS, the SRC in its 402nd Meeting held on 13th 14th September, 2021 has considered the matter and decided to issue a last reminder letter. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 07.10.2021. The institution has submitted its reply vide letter dated 01.11.2021.
- **6. AND WHEREAS,** the SRC in its 419th meeting held on 13th January, 2023 has considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 27.01.2023. The institution has submitted its reply vide letter dated 06.02.2023.
- 7. AND WHEREAS, the SRC in its 422^{nd} Meeting held on $02^{nd} 03^{rd}$ March, 2023 has considered the matter and decided to issue a last reminder letter. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 22.03.2023. The institution has not submitted reply to the last reminder letter.

8. AND WHEREAS, the SRC in its 423rd Meeting held on 12th April, 2023 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution has not submitted reply to the SRC last Reminder letter dated 22.3.2023 whereby it was informed that the institution has submitted a faculty list for B.Ed. Programme which is insufficient and is not as per NCTE Norms. Further the appointment orders and Salary disbursement details were also not furnished.

Hence, the committee decided to withdraw the recognition granted to the institution Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyapuri, Warangal-506009 Telangana for B.Ed. programme under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn."

- 9. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws the recognition granted to Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyapuri, Warangal-506009 Telangana for conducting B.Ed. programme of two years duration with an annual intake of (2 basic units) 100 students. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course.
- **10.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपैक्षा करता है, तो ऐसे पाठ्यक्रम

या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 11. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
