WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Vijyendra B.Ed. College, Yarnakanahally Road, Oorguampet, K.G.F-563131, Kolar District, Karnataka run by Saraswathi Educational Trust, K.G.F-563131, Kolar District, Karnataka vide order No. F. SRO/NCTE/B.Ed./2004-2005/9027 dated 02.12.2004 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 14.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC, Show Cause Notice was issued to the institution on 01.09.2022. The institution has submitted reply on 20.09.2022.
- **4. AND WHEREAS,** a letter dated 20.09.2022 has submitted by the institution for requesting to reduce from two units to one unit.
- **5. AND WHEREAS,** the SRC in its 422^{nd} meeting held on $02^{nd} 03^{rd}$ March 2023 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 05.04.2023. The institution vide dated 12.04.2023 has submitted a reply to the Final Show Cause Notice.
- 6. AND WHEREAS, the SRC in its 425th meeting held on 18th May 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Vijyendra B.Ed. College, Survey No. 14/77/3, Yarnakanahally Road, Oorguampet, K.G.F-563121, Kolar District, Karnataka for B.Ed. programme for 1 basic unit of 50 students."
