**CONTINUATION ORDER**

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Aravindhar College of Education, Thiruvalluvar Educational trust, Thenpallipattu Village, polur, Thiruvannamalai 606751, Tamilnadu run by Tiruvalluvar Educational Trust, Thenpallipattu Village, polur, Thiruvannamalai 606751, Tamilnadu vide order No. F.SRC/NCTE/2009/B.ED./RO/12736 dated 15.05.2009 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2009-2010.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 21.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 30.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.

3. AND WHEREAS, the SRC in 388<sup>th</sup> Meeting held on 14<sup>th</sup> & 15<sup>th</sup> September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a Show Cause was issued to the institution on 20.04.2022. The institution vide letter dated 27.05.2022 has submitted a reply to the Show Cause Notice.

4. AND WHEREAS, the SRC in its 413<sup>rd</sup> meeting held on 22<sup>nd</sup> – 23<sup>rd</sup> August 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision, the institution has submitted a reply to the Final Show Cause Notice on 16.09.2022.

5. AND WHEREAS, the SRC in its 414<sup>th</sup> meeting held on 26<sup>th</sup> – 27<sup>th</sup> September 2022 considered the matter and decided to issue a Last Reminder Letter. Accordingly, as per the decision of SRC, a Last Reminder Letter was issued to the institution on 12.10.2022.

6. AND WHEREAS, the SRC in its 413<sup>th</sup> meeting held on 22<sup>nd</sup> & 23<sup>rd</sup> August 2022 took note about the institution who have filled the PAR with certain deficiencies. In view of the above decision, the Regional Committee advised the Regional Director, SRC to

issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 27.01.2023.

7. **AND WHEREAS**, the SRC in its 425<sup>th</sup> meeting held on 18<sup>th</sup> May 2023 considered the matter and decided as under:-

***“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -***

*The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Aravindhar College of Education, Survey No. 58/1C, 59/1A, 59/1B, 59/1C, 59/2A, 59/2B, Thenpallipattu Panchayat, Thenpallipattu Village, polur, Thiruvannamalai 606751, Tamilnadu for B.Ed. programme for 2 basic units of 50 students each”.***

8. **NOW THEREFORE**, this order is issued permitting the institution i.e. Aravindhar College of Education, Survey No. 58/1C, 59/1A, 59/1B, 59/1C, 59/2A, 59/2B, Thenpallipattu Panchayat, Thenpallipattu Village, polur, Thiruvannamalai 606751, Tamilnadu run by Tiruvalluvar Educational Trust, Thenpallipattu Village, polur, Thiruvannamalai 606751, Tamilnadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of **2 basic unit of 100 students** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.



10. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

13. The institution shall make available the list of students admitted on its official website.

14. The institution shall fill the information on GIS Portal on the NCTE Website.



Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
