ORDER

WHEREAS, in the terms of Section 14(1) of the NCTE Act, 1993, the recognition was granted to the institution namely, **Chandy College of Education, No. 2/45, North Street, Muthiahpuram, Tutorin-628005, Tamilnadu** vide order no. F.SRO/NCTE/2007-2008/13588 dated 26.10.2007 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit dated 30.01.2015 for its willingness of two units in B.Ed. course and adherence provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its 392nd meeting held on 15th – 16th December, 2020 has considered the matter and decided to issue continuation order. Accordingly, as per the decision of SRC a Continuation order no. F. No. SRC/NCTE/TN/APSO4586/B.Ed. /392nd/ 2020/121403-1409 dated 22.12.2020 was issued to the institution.

4. **AND WHEREAS**, the institution has submitted written representations dated 09.11.2022 & 19.12.2022 reduction for **2 units to 1 unit**. The SRC in its 419th meeting held on 13th January, 2023 has considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 27.01.2023. The institution has submitted reply on 21.02.2023.

5. **AND WHEREAS**, the SRC in its 422nd meeting held on 02nd – 03rd March, 2023 has considered the matter and decided as under:-


