#### **ORDER**

WHEREAS, in the terms of Section 14(1) of the NCTE Act, 1993, the recognition was granted to the institution namely, Chandy College of Education, No. 2/45, North Street, Muthiahpuram, Tutorin-628005, Tamilnadu vide order no. F.SRO/NCTE/2007-2008/13588 dated 26.10.2007 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit dated 30.01.2015 for its willingness of two units in B.Ed. course and adherence provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its  $392^{nd}$  meeting held on  $15^{th}-16^{th}$  December, 2020 has considered the matter and decided to issue continuation order. Accordingly, as per the decision of SRC a Continuation order no. F. No. SRC/NCTE/TN/APSO4586/B.Ed. /392<sup>nd</sup>/ 2020/121403-1409 dated 22.12.2020 was issued to the institution.
- 4. AND WHEREAS, the institution has submitted written representations dated 09.11.2022 & 19.12.2022 reduction for <u>2 units to 1 unit</u>. The SRC in its 419<sup>th</sup> meeting held on 13<sup>th</sup> January, 2023 has considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 27.01.2023. The institution has submitted reply on 21.02.2023.
- 5. AND WHEREAS, the SRC in its 422<sup>nd</sup> meeting held on 02<sup>nd</sup> 03<sup>rd</sup> March, 2023 has considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee accepted the request made by the institution regarding reduction of the intake from 2 units to 1 unit. The Committee directed the RD, SRC to issue revised order accordingly."

6. NOW THEREFORE, in the terms of decision taken by SRC, the institution i.e., Chandy College of Education, No. 2/45, North Street, Muthiahpuram, Tutorin,
