WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Chellammal Teacher Training Institute, No. 17, Theni Road, Near Taluk Office, Andipatti-625512, Theni District, Tamilnadu run by Chellammal Educational Trust, S.V.S. Nagar, Andipatti, Theni District, Tamilnadu-625512 vide order no. F.SRO/NCTE/D.T.Ed/2006-2007/8671 dt. 24.10.2006 for D.T.Ed. course of two years duration with an annual intake of 50 students from the academic session 2006-2007.

2. AND WHEREAS, the institution has sent a letter dated 10.02.2023 and requesting that:-

"On the behalf of our Chellammal Educational Trust we run Chellammal Teacher Training Institute (D.El.Ed) from 2006-2007 APSO No.4678 from 2019-2020. We were stopped D.El.Ed. admission Because of lack students so our Tamilnadu SCERT sent to letter to us to stoppage of D.El.Ed. course. So we stopped admission from 2019-2020 onwards. So kindly withdraw our of D.El.Ed. course."

3. AND WHEREAS, the SRC in its 422nd Meeting held on 02nd & 03rd March, 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 10.02.2023 by withdrawing the recognition granted to Chellammal Teacher Training Institute, No. 17, Theni Road, Near Taluk Office, Andipatti-625512, Theni District, Tamilnadu for conducting D.T.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Chellammal Teacher Training Institute, No. 17, Theni Road, Near Taluk Office, Andipatti-625512, Theni District, Tamilnadu run by Chellammal Educational Trust, S.V.S. Nagar, Andipatti, Theni District, Tamilnadu-625512 for conducting D.T.Ed. programme of two years duration with an annual intake of 50 students from the academic session i.e., 2022-2023.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
