WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely J. J. Teacher Training Institute, J. J. Nagar, Sivapuram, Namanasamudram Post, Pudukottai, Tamilnadu-622404 run by Karpaga Vinayaga Educational Trust, Pudukottai, Tamilnadu-622404 for conducting Elementary course & D.T.Ed. course as per following details: -

- (i) Vide order no. F.TN/ELE/SRO/NCTE/2004-2005/1526 dt. 23.06.2005 for conducting Elementary course of two-years duration from the academic session 2005-2006 with an annual intake of 50 students.
- (ii) Vide order No. F.SRO/NCTE/D.Ed./2006-2007/7185 dt. 09.08.2006 for additional intake of 50 students in D.T.Ed. course of two years duration from the academic session 2006-2007 thus making a total annual intake of 100 students.
- 2. AND WHEREAS, the Southern Regional Committee (SRC) in its 412<sup>th</sup> meeting held on 5<sup>th</sup> & 6<sup>th</sup> July 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per decision of the SRC, a Show Cause Notice was issued to the institution on 05.08.2022 to Elementary course & D.T.Ed. programme. But the institution has failed to submit the reply of Show Cause Notice. Therefore, the Final Show Cause Notice issued on 07.09.2022 to Elementary & D.T.Ed. programme.
- 3. AND WHEREAS, the institution has submitted a written representation on 13.09.2022 as under: -

"We have received the Show Cause Notice from your office as cited in the references above. We would like to submit the following explanation to permit us to close the Institution.

The student's admission was nil in the academic year 2019-2020. Even for the Academic year 2018-2019 and 2017-2018 the admission of students was in single digit. The admission was less than 30% of the total intake. So, the State Council of Educational Research and Training (SCERT) issued final order no. 1731/1/2019 dt. 10.08.2020, instructing the institution not to admit students from 2020-2021. The copy of the order is enclosed for your perusal. So, we have not admitted the students for the following academic years. Further the State Government informed the institution to take steps to close the institution.

So, we hereby inform the office of Southern Regional Committee, National Council for teacher education, New Delhi about the willingness from the Management of Karpaga Vinayaga Educational Trust, Pudukkottai, Tamilnadu which runs the J.J Teacher Training Institute, Pudukkottai, Tamilnadu to close the institution.

We request your office to permit us to close and withdraw the amount available in the Joint Fixed Deposit Receipt and do the needful."

4. AND WHEREAS, the SRC in its 422<sup>nd</sup> Meeting held on 02<sup>nd</sup> & 03<sup>rd</sup> March, 2023 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 13.09.2022 by withdrawing the recognition granted to J. J. Teacher Training Institute, J. J. Nagar, Sivapuram, Namanasamudram Post, Pudukottai, Tamilnadu-622404 for conducting Elementary Course & D.T.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to J. J. Teacher Training Institute, J. J. Nagar, Sivapuram, Namanasamudram Post, Pudukottai, Tamilnadu-622404 run by Karpaga Vinayaga Educational Trust, (J. J. Teacher Training Institute), Post Box No. 22, Pudukottai, Tamilnadu-622001 for conducting annual intake of 50 students for Elementary course and for conducting D.T.Ed. programme of two years duration for additional intake of 50 students with effect from end of the academic session i.e., 2022-2023.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
