WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Arvinda Teacher Training Institute, Sanjay Nagar, Doddaballapur Town, Bangalore District, Karnataka-561203 run by Sri Arvinda Education Society, Doddaballapur, Bangalore Rural District, Karnataka vide order no. F.SRO/NCTE/D.Ed./2005-2006/5345 dt. 03.02.2006 for Elementary (D.Ed.) course of two and half years duration with an annual intake of 50 students.

2. AND WHEREAS, the institution has submitted a written representation dt. 28.02.2023 as

"With reference to the above subject, I wish to bring to your kind notice that Sri Aravinda Teacher Training Institute (Sri Arvinda D.Ed. College), Sanjay Nagar, Doddaballapur, Karnataka State, was stated during 2005-06 with the N.O.C. granted by the government of karnataka vide Ref (1) and as per recognition order vide ref (2) An Endowment fund of Rs. 5 lakhs and security deposit Rs. 3 lakhs were created in the joint names of the institution and the RD, SRC, NCTE Bangalore.

The Teacher Training Institute functioned well with from 2005-06 to 2016-17 and as there were no sufficient students available for DEd. Course we decided to close it in 2018-19.

As per our request, the Government of Karnataka issued N.O.C. for closure of Sri Aravinda Teacher Training Institute vide Ref (4).

Later, the DDPI (Training and principal, DIET, Bangalore Rural District approved the closure of the college and permitted us to withdraw the above said deposits, made in the joint names.

Having brought the above facts to your kind consideration, I hereby request your goodself to countersign the Deposit Certificates as shown vide ref (3), so that we can get back our amount of deposit."

3. AND WHEREAS, the SRC in its 422nd Meeting held on 02nd & 03rd March, 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 28.02.2023 by withdrawing the recognition granted to Arvinda Teacher Training Institute, Sanjay Nagar, Doddaballapur Town, Bangalore (R) District-561203, Karnataka for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Arvinda Teacher Training Institute, Sanjay Nagar, Doddaballapur Town, Bangalore (R) District-561203, Karnataka run by Sri Arvinda Education Society, Sanjay Nagar, Doddaballapur Town, Bangalore (R) District-561203, Karnataka for conducting Elementary Doddaballapur Town, Bangalore (R) District-561203, Karnataka for conducting Elementary (D.Ed.) course of two and half years duration with an annual intake of 50 students from the academic session i.e., 2022-2023.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such obtained pursuant to such course or training or after undertaking a course of employment under the institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."
