WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely G. S College of Physical Education, Survey No. 1171, 1076/1/2/3, Kolanthagoundanvalasu Village, Avinashipalyam Puthur Post, Kangayam Taluka & City, Erode District — 638701, Tamil Nadu vide order no. F.SRO/NCTE/SRCAPP15102 /B.P.Ed./TN/2016-2017/85136 dt. 02.05.2016 for B.P.Ed. programme of two years duration from the academic session 2016 - 2017 with an annual intake one basic unit of 100 (two sections of 50 students each).

- 2. AND WHEREAS, the SRC in its 388th Meeting held on 14th -15th September 2020 considered the matter and decided to issue a Show Cause Notice to the institution. Accordingly, as per decision of SRC, a Show Cause Notice was issued to the institution dated 24.05.2024. The institution has submitted reply vide letter dated 02.07.2024.
- 3. AND WHEREAS, the SRC in its 440th Meeting held on 03rd 04th July, 2024 has considered the matter and decided as follows: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

Regarding B.P.Ed. Programme

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution G.S College of Physical Education, Survey No. 1171, 1076/1/2/3, Kolanthagoundanvalasu Village, Avinashipalyam Puthur Post, Kangayam Taluka & City, Erode District – 638701, Tamil Nadu for B.P.Ed. programme 1 basic unit of 100 students."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e., G. S College of Physical Education, Survey No. 1171, 1076/1/2/3, Kolanthagoundanvalasu Village, Avinashipalyam Puthur Post, Kangayam Taluka & City, Erode District 638701, Tamil Nadu for Continuation of recognition for B.P.Ed. programme for two years duration with an annual intake of 1 basic unit of 100 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
