WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Venkateswara College of Education, Ambajipeta (Mandalam), East Godavari District-533214, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2008/6013 dated 10.10.2008 for conducting B.Ed. course of one year duration with an annual intake of 100 students from academic session 2008-2009.

- AND WHEREAS, on promulgation of NCTE Regulation 2014, the institution has submitted 2. an affidavit dt. 15.07.2015 for its willingness and adherence of provision of new Regulation. Thereafter, the Revised Provisional Recognition Order was issued to the institution on 30.06.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice issued on 28.02.2019. The institution had failed to submit reply.
- AND WHEREAS, the SRC in its 394th meeting held on 27th 28th January 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 04.03.2021. The institution has submitted reply on 31.05.2021.
- AND WHEREAS, the SRC in its 408th meeting held on 02nd March, 2022 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a withdrawal order vide F.SRO/NCTE/APSO9477/B.Ed./{AP}/2022/130737-130741 dated 14.03.2022 was issued to the institution.
- AND WHEREAS, the institution had filed a WP. No. 8957 of 2023 in the Hon'ble High Court of Andhra Pradesh at Amaravati, whereby the Hon'ble High Court vide its order dt. 23.01.2024 has directed that:-
 - "...6. In view of the fact that as rightly pointed out by the petitioner counsel since there are discrepancies in all the three notices i.e., the first show-cause notice was issued in the year 2019, final show-cause notice is of the year 2021 and withdrawal order is of the year 2022, this Court feels it appropriate to allow the Writ Petition by setting aside the withdrawal order vide No. F. SRO/NCTE/APS09477/B.Ed.(AP)/2022/ 30737, dated 14.03.2022 and the matter is remanded back to the 4th respondent-The National Council for Teacher Education for fresh consideration. The 4th respondent is directed to conduct a fresh enquiry by giving appropriate notice to the petitioner, and if at all any deficiencies are found with the petitioner institution, the respondents are at liberty to proceed in accordance with law.

- 7. Accordingly, the Writ Petition is allowed. There shall be no order as to costs."
- 7. AND WHEREAS, the SRC in its 433rd Meeting held on 10th February, 2024 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC, a Show Cause Notice was issued on 14.02.2024. The institution has submitted its reply on 31.05.2024.
- **8. AND WHEREAS,** the SRC in its 438th Meeting held on held on 03rd June, 2024 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 21.06.2024. The institution has submitted reply on 29.06.2024.
- 9. AND WHEREAS, the SRC in its 440^{th} meeting held on $03^{rd} 04^{th}$ July, 2024 considered the matter and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Venkateswara College of Education, Survey No. 279/1, Ambajipeta (Mandal), East Godavari District-533214, Andhra Pradesh for B.Ed. programme 1 basic unit of 50 students."

- 10. NOW THEREFORE, this order is issued permitting the institution i.e., Venkateswara College of Education, Survey No. 279/1, Ambajipeta (Mandal), East Godavari District-533214, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the

programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
