WHEREAS, the recognition was granted to the institution namely, National College of Education, Hafth Gumbad, Darga Road, Gulbarga, Karnataka-585104 for B.Ed., & M.Ed. programme as per following details:-

- (i) The SRC vide Order No F.SRO/NCTE/B.Ed./2004-2005/8735 dated 29.11.2004 for Secondary B.Ed. course of one-year duration with an annual intake of 100 students from the academic sessions 2004-2005.
- (ii) The SRC vide order No. F.SRO/NCTE/APS09350/M.Ed./KA/2021/129253 dt. 22.09.2008 for conducting M.Ed. programme of one-year duration with an annual intake of 25 students.
- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 17.01.2015 for its willingness of two units in B.Ed. & M.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 & 26.05.2015 for conducting B.Ed. & M.Ed. course of two years duration with an annual intake of 100 students (two basic units) & 50 students (1 basic unit) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 404<sup>th</sup> Meeting held on 16<sup>th</sup> & 17<sup>th</sup> November, 2021 considered the matter and decided to issue continuation order. Accordingly, as per the decision of SRC a continuation order no. F.SRO/NCTE/APSO1830/B.Ed/KA/2021/129279 and F.SRO/NCTE/APS09350/M.Ed./KA/2021/129253 dated 29.11.2021 was issued to the institution.
- 4. AND WHEREAS, the institution has submitted application for shifting vide letter dated 27.02.2024 along with documents. The SRC in its 434<sup>th</sup> meeting held on 22<sup>nd</sup> March, 2024 considered the matter and decided to constitute the online VT. The inspection was conducted on 18.06.2024 and Vt report received on 21.06.2024.
- 5. AND WHEREAS, the SRC in its  $440^{th}$  meeting held on  $03^{rd}-04^{th}$  July, 2024 considered the matter and decided as under: -
