WHEREAS, the recognition was granted to the institution MAM Teacher Training Institute, MAM Nagar, Trichy-Chennai Trunk Road, Siruganur, Trichy District-621105 run Maluk Educational Health and Charitable Trust, No.49, Raja Colony, Collector Office Road, Tiruchirappalli, District-620001, Tamilnadu vide SRC order F.SRO/NCTE/2007-2008/7357 dt. 26.11.2008 for conducting B.P.Ed. course of one-year duration with an annual intake of 50 students.

- 2. AND WHEREAS, The SRC in its 294th meeting held on 14th November to 16th November 2015 the committee considered the matter & decided to issue Show Cause Notice. As per decision of SRC, a show cause notice was issued to the institution on 05.04.2016. Another show cause notice was issued to the institution on 23.05.2018.
- 3. AND WHEREAS, the institution vide dated 04.07.2018 submitted a written representation in response to Show Cause Notice. The institution stating as under: -

"With reference your letter cited above 23.05.2018 on this date. Oue M.A.M College of Education has run B.Ed. Programme only since – 2009. Now you have asked the affidavit of NCTE new regulation 2014 for Programme of B.P.Ed. But our institution didn't run B.P.Ed. course. So we unable to send the affidavit of NCTE regulation 2014. We request you to consider upon this matter. We hope that our entreaty will be fulfilled.

Note:-

Kindly close the application of B.P.Ed. Programme as soon as Possible earliest. B.P.Ed. Course vide order F.SRO/NCTE/2007-2008/7357, dated 25.11.2008".

4. AND WHEREAS, the matter was further considered by the SRC in its 397^{th} meeting held on March $25^{lh}-26^{th}$, 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution by its letter dated 04.07.2018 by withdrawing the recognition granted to M.A.M. Teacher Training Institute, M.A.M. Nagar, Trichy Chennai Trunk Road, Siruganur, Trichy District-621105, Tamilnadu for conducting B.P.Ed. course under clause 17(1) of NCTE Act, 1993 with effect from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to M.A.M. Teacher Training Instittute, M.A.M. Nagar, Trichy Chennai Trunk Road, Siruganur, Trichy District-621105, Tamilnadu run by Maluk Educational Health and Charitable Trust, No.49, Raja Colony, Collector Office Road, Tiruchirappalli, District-620001, Tamilnadu for conducting B.P.Ed. course of one years duration with an annual intake of 50 students w.e.f. the academic session 2021-2022.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or In any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
