WITHDRAWAL ORDER**

WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely Nova College of Education, R.S. No. 47/1B, Ibrahimpatnam, Krishna District-521456, Andhra Pradesh vide order no. F.SRO/NCTE/M.Ed./2006-2007/6143 dt. 09.07.2007 for conducting M.Ed. Course of one year duration with an annual intake of 25 students.

2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 was permitted to Nova College of Education, R.S. No. 47/1B, Ibrahimpatnam, Krishna District-521456, Andhra Pradesh vide order No. F.SRO/NCTE/2010-2011/20630 on 24.08.2010 from the session 2010-2011.

3. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated nil. A revised provisional recognition order was issued on 31.05.2015 to the institution for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.

4. AND WHEREAS, the SRC in its 315th meeting held on 17th – 18th June, 2016 has considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 13.07.2016.

5. AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 29.11.2019. The institution has not submitted reply to the Final Show Cause Notice.

6. AND WHEREAS, the SRC in its 412th meeting held on 05th – 06th July, 2022 has considered the matter and the following observations were made:

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- (i) The institution was issued a Final Show Cause Notice on 29.11.2019. The institution failed to submit reply along with the requisite documents/information to the Final Show Cause Notice (FSCN). The Committee also noted that the institution has not even filed Performance Appraisal Report (PAR).

Hence the recognition granted to **Nova College of Education, Vijaywada Revenue Division, Ibrahimpatnam, Mandal Krishna District-521456, Andhra Pradesh** for **B.Ed. & M.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. **2023-2024**.”

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Nova College of Education, R.S. No. 47/1B, Ibrahimpatnam, Krishna District-521456, Andhra Pradesh** for conducting **M.Ed. Programme** of two years duration with an annual intake of **50 students (one basic unit)** with effect from the end of next academic session i.e., **2023-2024**. Further, *on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counseling from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.*

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
