**WITHDRAWAL ORDER**

WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Dr. B.V. Syamala Ratnam College of Education, Srinivasa Nagar, Behind Surya Coach factory, Appalalkunta, Hindupur, Anantapur – 515201, Andhra Pradesh vide order no. F.SRO/NCTE/B.Ed/2006-2007/3328 dt. 25.05.2007 for conducting B.Ed. Course of one year duration with an annual intake of 100 students.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 17.01.2015. A revised provisional recognition order was issued on 06.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. AND WHEREAS, a corrigendum vide order no. F.SRO/NCTE/APS07015/B.Ed./KA/2015/69636 dt. 09.07.2015 for grants of recognition to Dr. B.V. Syamala Ratnam College of Education, Srinivasa Nagar, Behind Surya Coach factory, Appalalkunta, Hindupur, Anantapur – 515201, Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016 was issued.

4. AND WHEREAS, the Dean, CDC Sri Krishnadevaraya University had informed under his signature that the affiliation for the year 2018-2019 was not extended to Dr. B.V. Syamala Ratnam College of Education.

5. AND WHEREAS, the SRC in its 410<sup>th</sup> meeting held on 25<sup>th</sup> – 26<sup>th</sup> April, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 12.05.2022. The institution has not submitted reply to the Final Show Cause Notice.

6. AND WHEREAS, the SRC in its 412<sup>th</sup> meeting held on 05<sup>th</sup> – 06<sup>th</sup> July, 2022 has considered the matter and the following observations were made:

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- (i) The institution was issued a Final Show Cause Notice on 12.05.2022. The institution failed to submit reply along with the requisite documents/information to the Final Show Cause Notice (FSCN). The Committee also noted that the institution has not even filed Performance Appraisal Report (PAR).

Hence the recognition granted to **Dr. B.V. Syamala Ratnam College of Education, Srinivasa Nagar, Behind Surya Coach factory, Appalalkunta, Hindupur, Ananthpur – 515201, Andhra Pradesh** for **B.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. **2023-2024.**”

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Dr. B.V. Syamala Ratnam College of Education, Srinivasa Nagar, Behind Surya Coach factory, Appalalkunta, Hindupur, Ananthpur – 515201, Andhra Pradesh** for conducting **B.Ed. Programme** of two years duration with an annual intake of **50 students (one basic unit)** with effect from the end of next academic session i.e., **2023-2024**. Further, *on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counseling from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.*

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

*“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”*

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
