WHEREAS, the recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, University College of Education, Sri Krishnadevaraya University, Ananthpur, Andhra Pradesh-515003 vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2007-2008/11911 dt. 25.09.2007 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 21.01.2015. A revised provisional recognition order was issued on 06.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 298th Meeting held on 08th to 10thJanuary, 2016 considered the matter and other relevant documents of the institution, and decided to "Issue SCN for inadequate faculty in M.Ed. B.Ed. and B.Ed.-(DE).
- **4. AND WHEREAS**, the SRC in its 307th Meeting held on 09th March, 2016 considered the reply of the institution and decided as under:-
 - 1. The reply is not at all satisfactory. Regular B.Ed. & M.Ed. are being run by adhoc teachers. The B.Ed. (DE) is being handled by teachers attached form other Colleges.
 - 2. Withdraw Recognition.
- **5. AND WHEREAS**, the SRC in its 326th Meeting held on 04th& 05thJanuary, 2017 again considered the matter and decided to issue Withdrawal order. Accordingly, as per decision of SRC withdrawal order was issued to the institution vide order no. F.SRO/APS07494/B.Ed./APS00414/M.Ed./AP/2016-2017/91302 dt. 24.01.2017 for B.Ed. and M.Ed. programme.
- 6. AND WHEREAS, aggrieved by withdrawal order of SRC, the institution preferred an appeal with NCTE-Hqrs. and NCTE Appellate Authority in its order no. F.No.89-216/2017Appeal/13th Meeting -2017/57081 dated 21.08.2017 received by this office on 29.08.2017 "remanded to the SRC with a direction to consider the teaching faculty provided by the appellant and take further action as per the NCTE Regulations, 2014."
- 7. AND WHEREAS, the University submitted its written representation along with faculty list and other documents on 20.12.2017. The SRC in its 352nd Meeting held on 04th 805th January, 2018 considered the matter and decided to issue Show Cause Notice.

Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 16.01.2018. The University has submitted its reply on 05.02.2018.

- **8. AND WHEREAS,** the SRC in its 358th Meeting held on 01st to 03rd March, 2018 considered the matter and decided to issue restore/continued order. Accordingly, as per decision of SRC restore/continued order issued to the institution on 03.03.2018 from academic session 2017-2018.
- 9. AND WHEREAS, the SRC in its 388th considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 22.02.2021. The institution has submitted its reply on 15.03.2021.
- 10. AND WHEREAS, the SRC in its 411st meeting held on 23rd -24th May, 2022 has considered the matter and the decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 02.06.2022. The institution has not submitted reply to the Final Show Cause Notice.
- **11. AND WHEREAS**, the SRC in its 412th meeting held on 05th 06th July, 2022 has considered the matter and the following observations were made:

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

(i) The institution was issued a Final Show Cause Notice on 02.06.2022. The institution failed to submit reply along with the requisite documents/information to the Final Show Cause Notice (FSCN). The Committee also noted that the institution has not even filed Performance Appraisal Report (PAR).

Hence the recognition granted to University College of Education, Sri Krishnadevaraya University, Anantapur – 518002, Andhra Pradesh for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. 2023-2024."

12. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to University College of Education, Sri Krishnadevaraya University, Anantapur – 518002, Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 50 students each (two basic units) with effect from the end of next academic session i.e., 2023-2024 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counseling

from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.

13. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

14. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
