- The institution shall, within one month of the receipt of recognition order, convert the environment famil account into a joint account to be operated along with an official of the Southern Regional Committee.
- C The institution shall shift to its own premises / building within three years from the date of recognition (in case the course is started in rented premises)
- d. The institution shall comply with the various other norms and standalds prescribed in the NCTE Regulations.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of facuity members, and the statement of annual accounts duly audited by a Chartered Accountant.
