CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Pragathi College of Education, No. 130/B and 135/D, Village- Durki, Post- Durki, Taluk- Banswada, City-Banswada, Nizamabad District- 503187, Andhra Pradesh vide SRC (NCTE) order No F.SRO/NCTE /B.Ed/2010/20509 dated 19.08.2010 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2010-11.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 18.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 28.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. AND WHEREAS, the institution has submitted documents as per revised order on 31.10.2015. The SRC in its 314th meeting held on 27th to 28th May 2016, decided to issue a inspection letter. Accordingly, as per the decision of SRC inspection intimation was sent to the institution on 14.06.2016. As per the decision of SRC, VT assigned through online procedures The inspection of the institution was conducted on 08.10.2016 and VT report along with documents and CD received on 17.10.2016.

4. AND WHEREAS, the SRC in its 381th meeting held on 31st Oct & 1st Nov, 2019 decided to issue Show Cause Notice to all such institution where compliance /representation has not been submitted by the institution. Accordingly, as per the decision of SRC a first show cause notice was issued to the institution on 19.11.2019. The institution vide letter dated 07.12.2019 submitted its reply to the first show cause notice

5. AND WHEREAS, the SRC in its 384th meeting held on 12th & 13th February 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 26.02.2020. The institution has submitted reply of Final Show Cause Notice on 19.03.2020.

6. AND WHEREAS, the SRC in its 401st meeting held on 11th – 12th August considered the matter and decided withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRO/NCTE/APS09643 /B.Ed./TS/2021/08441 dated 28.08.2021 was issued to the institution.

7. AND WHEREAS, Aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-256/E-197559/2021 Appeal/20th Meeting, 2021 APPLSRC202114111 dated 22.10.2021 appeal remand back the order appealed against. The institution has submitted reply of Appeal Remand Case on 29.10.2021

8. AND WHEREAS, the SRC in its 404th meeting held on 16th – 17th November, 2021

considered the matter and decided as under:

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

‘The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Pragathi College of Education, Survey No. 130/B and 135/D, Village- Durki, Main Road, Near Banswada, Post- Durki, Taluk- Banswada, Nizamabad District- 503187, Telangana for B.Ed. programme for 2 basic units of 50 students each”.

9. NOW THEREFORE, this order is issued permitting the institution i.e. Pragathi College of Education, Survey No. 130/B and 135/D, Village- Durki, Main Road, Near Banswada, Post- Durki, Taluk- Banswada, Nizamabad District- 503187, Telangana run by Pragathi Educational Society, No. 130/B and 135/D, Village- Durki, Post- Durki, Taluk- Banswada, Nizamabad District- 503187, Telangana for continuation of recognition for B.Ed. Programme for two years duration (2 basic units) of 50 students each subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FEDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter.
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;

- g. Facilities added during the last quarter;
h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
i. The affidavit with enclosure submitted along with application.
j. The institution shall be free to post additional relevant information if it so desires.
k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
