WHEREAS, the recognition u/s 14 of NCTE Act. 1993 was granted to the institution namely Virudhunagar M.S.P. Nadar College of Education, Virudhunagar District-626001, TamilNadu run by Virudhunagar Indu Nadarlukku Pathiamana Senthikumara Nadar Uyarthara Kalluri Paripalana Sabai, Virudhunagar-626001, TamilNadu vide order F.SRO/NCTE/B.Ed./2006-2007/17456 dated 30.01.2008 for conducting B.Ed. programme of two-years duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 11.05.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 25.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388^{th} meeting held on $14^{th}-15^{th}$ September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 27.12.2021.
- 4. AND WHEREAS, the institution vide letter dated 23.02.2022 has submitting an application for shifting of premises along with Demand Draft No.439855 for Rs. 1.5 Lakhs in favour of Member Secretary, NCTE, New Delhi and relevant documents.
- 5. AND WHEREAS, the SRC in its 409th meeting held on 29th 30th March 2022 has considered the matter and decided to constitute the Visiting team for shifting of premises for inspection from <u>Virudhunagar M.S.P. Nadar College of Education, Virudhunagar District-626001, TamilNadu to Survey No. 287, 289, Periyavallikulam Panchayat, Virudhunagar-626001, TamilNadu.</u> Accordingly, as per the decision of SRC inspection of the institution was conducted on 16.04.2022 & 17.04.2022 and the Visiting team report was received by this office on 25.04.2022.
- **6. AND WHEREAS,** the SRC in its 412th meeting held on 05th 06th July 2022 has considered the Visiting Team Report for shifting of premises and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 26.07.2022. The institution vide letter dated 31.07.2022 has submitted a reply to the Final Show Cause Notice.
- 7. AND WHEREAS, the SRC in its 413th meeting held on 22nd & 23rd August 2022 considered the matter and decided as under:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Virudhunagar M.S.P. Nadar College of Education, Survey No. 287, 289, Periyavallikulam Panchayat, Virudhunagar-626001, TamilNadu for B.Ed. programme for 2 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Virudhunagar M.S.P. Nadar College of Education, Survey No. 287, 289, Periyavallikulam Panchayat, Virudhunagar-626001, TamilNadu run by Virudhunagar Indu Nadarlukku Pathiamana Senthikumara Nadar Uyarthara Kalluri Paripalana Sabai, College Road, Virudhunagar-626001, TamilNadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.
