WHEREAS, recognition u/s14 of NCTE Act, 1993 was granted to the institution namely, Gourishetti Venkataiah Memorial College of Education, H. No. 3-7-918/A, Gourishetty Venkataiah Nagar, Jagatial Road, Karimnagar-505001, Telangana run by Karimnagar Educational Society, 1340, 50, Jagtial Road, Karimnagar, Telangana vide (NCTE) order no. F.AP/NEW/B.Ed/SRO/ NCTE/2002-2003/6664 dated 04.04.2003 for conducting B.Ed. (Secondary) Course of one year duration with an annual intake of 100 students from the academic session 2002-2003.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.17.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 19.03.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in its 381st Meeting held on 31st October & 01st November 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 05.11, 2019. The institution has not submitted reply of show cause notice.
- **4. AND WHEREAS,** the SRC in its 412th meeting held on 05th 06th July 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 26.07.2022. The institution has submitted a reply to the Final Show Cause Notice on 28.07.2022.
- **5. AND WHEREAS,** the SRC in its 413th Meeting of SRC held on $22^{nd} 23^{rd}$ August 2022 considered the matter and deficiencies in reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its vide letter dated 21.07.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.

1. The institution has submitted copy of letter of the affiliating body and the detailed format of faculty is not signed by the affiliating University

- and date of appointment are also not mentioned in the said format as per NCTE Regulations.
- 2. The institution has submitted a Land Use Certificate which is neither in the name of the institution nor in the name of Society.
- 3. The building plan is not approved by the competent authority.
- 4. The Building Completion Certificate is not approved by the Competent Authority.
- 5. The institution has submitted certificate of bank towards joint conversion of FDRs towards Endowment Fund and Reserve Fund totally sum of 12 lakhs instead of original Form 'A' and copies of FDRs.
- 6. No proof submitted by the institution in building plan the campus, building are barrier free and separate toilet for male and female student for staff and for PWD.
- 7. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence the recognition granted to Gourishetti Venkataiah Memorial College of Education, H. No. 3-7-918/A, Gourishetty Venkataiah Nagar, Jagatial Road, Karimnagar-505001; Telangana for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted Gourishetti Venkataiah Memorial College of Education, H. No. 3-7-918/A, Gourishetty Venkataiah Nagar, Jagatial Road, Karimnagar-505001, Telangana run by Karimnagar Educational Society, 1340, 50, Jagtial Road, Karimnagar, Telangana for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn".
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University,



or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
