WHEREAS, recognition u/s15 Act of NCTE, 1993 was granted to the institution namely, Rayapati Venkata Ranga Rao College of Education, JKC College Road, Guntur -522006, Andhra Pradesh vide order No. F.SRO/NCTE/M.Ed-Al/2006-2007/3077 dated 21.05.2007 for conducting (M.Ed.) Course of one year duration with an annual intake of 40 students.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 19.01.2015. A revised provisional recognition order was issued on 26.05.2015 to the institution for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided to that the Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC, a Show Cause Notice issued on 31.01.2019. The institution has submitted reply on 23.02.2019.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov. 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice issued to the institution on 29.11.2019. The institution has submitted reply on 16.12.2019.
- AND WHEREAS, the SRC in its 412th meeting held on 05th 06th July, 2022 5. considered the matter and decided to issue a last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 26.07.2022. The institution has submitted reply on 18.08.2022.
- AND WHEREAS, the institution vide letter dated 18.08.2022 has submitted request 6. to close the M.Ed. Programme. The SRC in its 413th Meeting held on 22nd - 23rd August, 2022 considered the request for close the M.Ed. Programme matter and decided as under: -

The Committee agreed to close down the M.Ed. programme as requested by the Management vide their letter dated 18.08.2022 by withdrawing the recognition granted to Rayapati Venkatta Ranga Rao College of Education, JKC College Road, Guntur - 522006, Andhra Pradesh for conducting M.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting.

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Rayapati Venkatta Ranga Rao College of Education, JKC College Road, Guntur 522006, Andhra Pradesh for conducting M.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) with effect from the end of next academic session i.e., 2022-2023. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
