WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution M.A.E.T. Training College, Nettayam, Kachani P.O. Thiruvananthapuram - 695013, Kerala Vide SRC (NCTE) order No F.SRO/219/NCTE/B.Ed./2004-2005/763 dt. 23.02.2005 for conducting Secondary course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 27.11.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on13.01.2016 for conducting B.Ed. course of two years duration with an annual intake of 50 students (One basic unit) from the academic session 2015-2016.
- AND WHEREAS, the institution vide letter dated 11.09.2017 requested for the closure of institution.
- ANDWHEREAS, SRC vide letter F. No.SRO/NCTE/APS00437/B.Ed./KL/2017-18/95446 dated 31.10.2017 directed the institution to submit the following documents for the closure of the B.Ed. Programme. i) Resolution of the Society. ii) No dues from the staff. iii) No objection from the affiliating body. The institution did not submitted any reply.
- AND WHEREAS, SRC, NCTE again send a letter to the institution vide letter No. F.No. SRO/NCTE/APS00437/B.Ed./KL/2018-19/111773 dated 14.11.2019 to submit the documents for the closure of the institution. No reply received from the institution.
- AND WHEREAS, finally, NCTE send an email to the institution on 26.02.2020. Meanwhile, the Deputy Registrar (Acadl), University of Kerala, Thiruvananthapuram, Kerala vide letter No. Ac.BII/01/27783/2019 dated 18.10.2019 has forwarded a list of teacher training institutions who are not enrolling students for various reasons and M.A.E.T. Training College, Nettayamis one of them. No reply received from the institution till date.

- **8. AND WHEREAS,** the matter was further considered by the SRC in its 386th meeting held on 23rd & 24th July, 2020 and the Committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on **05.08.2020** to reply within 21 days. No reply received from the institution.
- 9. AND WHEREAS, the matter was further considered by the SRC in its 395^{th} meeting held on 25^{th} 26^{th} February ,2021 and the Committee decided as follows:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The Committee noted that due to non-compliance of Email dated **26.02.2020** for submission of requisite documents to verify infrastructure & instructional facilities a Final Show Cause Notice dated **05.08.2020** was issued to the institution. However the institution failed to submit the requisite documents as per Final Show Notice dated **05.08.2020**.

Hence, the Committee decided to withdraw the recognition granted to M.A.E.T. Training College, Nettayam, Kachani P.O. Thiruvananthapuram-695013, Kerala for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 10. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to M.A.E.T. Training College, Nettayam, Kachani P.O. Thiruvananthapuram-695013, Kerala for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- **11.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such

institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

12. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
