#### WITHDRAWAL ORDER

WHEREAS, the institution namely Audi Sankara College of Education, NH-5, Bypass Road, Gudur, Nellore, Andhra Pradesh-524101 run by Aishwarya Vignan Educational Society, Nellore, Andhra Pradesh was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/3691 dt. 05.06.2007 for conducting B.Ed. (Secondary) course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

**AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-16 with a condition to maintain.

**AND WHEREAS,** the institution submitted written representation on dt. 27.01.2016.

**AND WHEREAS,** the SRC in its 321<sup>st</sup> Meeting held on 28<sup>th</sup> & 29<sup>th</sup> September 2016 considered the matter and decided to issue a letter to the institution. Thereafter, a letter was issued to the institution on dt. 08.11.2016.

**AND WHEREAS,** the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> Meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice was issued to the institution on dt. 18.02.2019.

**AND WHEREAS,** the matter was placed before the SRC in its 395<sup>th</sup> Meeting held on 25<sup>th</sup> & 26<sup>th</sup> February 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The Committee noted that due to non-compliance of SCN dated 18.12.2019 for submission of requisite documents to verify infrastructure & instructional facilities a Final Show Cause Notice dated 30.12.2020 was issued to the institution. However, the institution failed to submit the requisite documents as per Final Show Notice dated 30.12.2020.

Hence, the Committee decided to withdraw the recognition granted to Audi Sankara College of Education, NH-5, Bypass Road, Gudur, Nellore-524101, Andhra Pradesh for conducting B.Ed. course with effect from the next academic session i.e., 2021- 2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to Audi Sankara College of Education, NH-5, Bypass Road, Gudur, Nellore, Andhra Pradesh-524101 run by Aishwarya Vigan Educational Society, Gudur, Nellore District, Andhra Pradesh-524101 for conducting B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students with effect from the next academic session i.e., 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a>, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
