# TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, TDTA D.S. Daniel, Rajammal College of Education for Women, Ilanji, Tenkasi Taluk, Tirunelyeli, Tamilnadu-627805 run by The Church of South India-Tirunelveli Diocese, Tirunelveli District, Tamilnadu vide order no. F.SRO/NCTE/B.Ed./2007-2008/14106 dt. 05.11.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 13.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 11.11.2021. The institution has submitted reply on 23.11.2021.
- AND WHEREAS, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 29.12.2021. The institution has submitted reply on 19.01.2022 & 02.02.2022.
- 5. AND WHEREAS, the SRC in its 407th Meeting held on 15th February, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 19.01.2022 & 02.02.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution failed to submit latest staff list as directed vide Final Show Cause Notice dt. 29.12.2021.
- 2. The institution failed to submit the bank statement of faculty showing disbursement of salary through bank Account as required under clause 10 (2) of NCTE Regulations, 2014 but the institute did not submit the same and only bank account numbers and amount has been submitted and that too is not attested by the bank.

3. The institution has not submitted approved building plan.

4. The institute failed to submit satisfactory reply in respect of mortgaged land shown in previous NEC.

Hence, the Committee decided to withdraw the recognition granted to TDTA D.S Daniel Rajammal College of Education for Women, iianji, Tenkasi Taluk, Tirunelveli-627805, TamilNadu for conducting B.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to TDTA D.S Daniel Rajammal College of Education for Women, iianji, Tenkasi Taluk, Tirunelveli-627805, TamilNadu run by The Church of South India-Tirunelveli Diocese, Tirunelveli District, Tamilnadu-627805 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

**8.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
