WHEREAS, the recognition was granted to the institution Presidency College of Education, H.No. 19-3-159, Jahanuma, Near Falaknuma Bus Depot, Hyderabad, Andhra Pradesh vide order No. F.SRO/NCTE/D.Ed/2008-09/4458 dated 30.08.2008 for conducting (D.Ed.) course of two-year duration with an annual intake of 50 students from the academic session 2008-2009.

- **2. AND WHEREAS**, the SRC in its 250th meeting held on 11th 13th August, 2013 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.No.APS07048/D.Ed./AP/2013-14/54109 dated 30.09.2013 was issued to the institution.
- **3. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-651/2013 Appeal/1st Mtg. 2014/A84863 dated 14.03.2014 appeal remand back the order appealed against. The institution has submitted reply on 01.01.2015.
- **4. AND WHEREAS,** the SRC in its 276th meeting held on 07th 09th January, 2015 considered the matter and decided to restore the recognition. Accordingly, as per the decision of SRC restoration order no. F.No./SRC/NCTE/APS07048/D.Ed./AP/2015/62714 dated 19.03.2015 was issued to the institution.
- **5. AND WHEREAS**, the institution vide letter dated 03.01.2020 has submitted request to closure the D.Ed. Programme. The SRC in its 407th Meeting held on 15th February, 2022 considered the request for close the D.Ed. Programme matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the society vide letter dated 03.01.2020 by withdrawing the recognition granted to **Presidency College of Education, No 19-3-159, Jahanuma, Near Falaknuma Bus Depot, Hyderabad-500053, Telangana** for conducting **D.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to *Presidency College of Education, No 19-3-159, Jahanuma, Near Falaknuma Bus Depot, Hyderabad-500053, Telangana* for conducting **D.Ed. programme** of two years duration with an annual

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
