# TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Peet Memorial Training College, P.O. Box 10, Mavelikara, Alappuzha-690101, Kerala vide order no.F.KI/Sec/14/SRO/NCTE/1999-2000/5231 dt.22.03.2000 for conducting B.Ed. Course with an annual intake of 150 students.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has 2. consented to come under new Regulations vide a notarized affidavit dated 28.01.2015 and the provisional revised recognition order was issued on 26.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 150 students (three basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 383rd meeting held on 07th 09th January 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 22.01.2020. The institution has submitted a reply on 24.02.2020.
- AND WHEREAS, the SRC in its 408th Meeting of SRC held on 02nd March 2022 considered the reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 24.02.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted faculty list but not approved by Affiliating Body as per NCTE Regulation 2014.
  - The institution has submitted faculty for B.Ed. Programme 150 (i) students 10 faculty against the requirement of 22 faculty as per NCTE Regulation 2014.
  - The institution has submitted faculty for M.Ed. Programme 50 (ii) students 05 faculty against the requirement of 10 faculty as per NCTE Regulation 2014.
  - Two Professors for M.Ed. course not appointed.

The institution also failed to submit supporting documents in terms of educational qualification of the faculty and experience certificate of the Principal.

- 2. The institution has submitted attested copy of Building Plan in which total Built-up area, survey Nos. are not mentioned, not approved by competent authority.
- 3. The institution has not submitted Building Completion Certificate.
- 4. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014
- 5. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to Peet Memorial Training College, Mavelikara, Alappuzha Dist., Pin-690101, Kerala for conducting B.Ed. & M.Ed. programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Peet Memorial Training College, Mavelikara, Alappuzha Dist., Pin-690101, Kerala run by CSI Diocese and Church Mission Society, Mavelikara, Alappuzha Dist., Pin-690101, Kerala for conducting B.Ed. Programme of two years duration with an annual intake of 150 students (3 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
