WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Hemadri B.Ed. College, Murandahalli Cross, Arahalli Post, Srinivasapura Road, Kolar-563101, Karnataka vide SRC (NCTE) order no.F.SRO/NCTE/B.Ed./2004-2005/8652 dt.25.11.2004 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 30.01.2015 and the provisional revised recognition order was issued on 16.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 4. AND WHEREAS, the SRC in its 350th Meeting held on 21st & 22nd December, 2017 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 04.01.2018. The institution has submitted reply on 18.01.2018.
- 5. AND WHEREAS, the SRC in its 406th Meeting held on 19th January, 2022, considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 02.02.2022. The institution has submitted reply on 16.02.2022.
- 6. AND WHEREAS, the SRC in its 408th Meeting of SRC held on 02nd March 2022 considered the reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 16.02.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institute submitted a Performa of 8 Faculty but the same is not approved/signed by the Registrar of University. Further the strength of faculty is not sufficient for one unit of B.Ed. course as required under NCTE Regulations, 2014.
- 2. Approval given by the Registrar, Bengaluru North University vide letter dt. 26.12.2019 is conditional for 5 Faculty to clear the NET. Accordingly,

- Faculty is not qualified as per NCTE Regulations, 2014 (amended vide notification dt. 09.06.2017).
- 3. The building plan and BCC submitted by the institute shows the size of M.P. Hall as 1520 sq. ft. which is less than the requirement of NCTE Regulations.
- 4. The institute failed in submission of bank statements of faculty showing disbursement of salary through bank account as required under clause 10 (3) of NCTE Regulations, 2014 and directed to submit vide Final Show Cause Notice dt. 02.02.2022.

Hence, the Committee decided to withdraw the recognition granted to Hemadri B.Ed. College, Murandahalli Cross, Arahalli Post, Srinivasapura Road, Kolar, Karnataka-563101 for conducting B.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Hemadri B.Ed. College, Murandahalli Cross, Arahalli Post, Srinivasapura Road, Kolar, Karnataka-563101 run by Sri Hemadri Educational Trust, Kolar-563101, Karnataka for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
