- 4. Further, recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government, etc.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a
- 6. This Order of recognition is subject to the outcome of C.A.No.7756, 7757 & 7758 of 2001 filed before the Hon'ble Supreme Court against order of the Hon'ble Division Bench in W.A.No. 626/2000 of the Hon'ble High Court of Andhra Pradesh.
- 7. If the institution contravenes any of the above condition or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act.
