WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Acharya Deshbhushan College of Education, Shantinagar, Shamanewadi (Behind Circle), Chikodi, Belgaum District, Karnataka-591214 run by Shri Bhadrabahu Rural Minority Education Society, Chikodi, Belgaum District, Karnataka vide order no. F.SRO/NCTE/B.Ed./2004-2005/9050 dt. 02.12.2004 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 01.02.2015. The Southern Regional Committee (NCTE) issued the Revised Provisional Recognition Order to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic unit) from the academic session 2015-2016.
- 3. **AND WHEREAS**, the SRC in its 388^{th} Meeting held on $14^{th} 15^{th}$ September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC, Show Cause Notice was issued to the institution on 01.09.2022. The institution has submitted its reply dt. 20.10.2022.
- 4. **AND WHEREAS.** the SRC in its 421st Meeting held on 10th February, 2023 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 20.02.2023. The institution did not submit any reply to Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 434th Meeting held on 22nd March, 2024 considered the matter and decided as under: -

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 20.02.2023.

Hence the recognition granted to Acharya Deshbhushan College of Education, Shantinagar, Shamanewadi (Behind Circle), Chikodi, Belgaum District, Karnataka-591214 for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdrawing the recognition granted to Acharya Deshbhushan College of Education, Shantinagar, Shamanewadi (Behind Circle), Chikodi, Belgaum District, Karnataka-591214 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units). No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(7. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
