CONTINUATION ORDER

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Anwaru Uloom College of Education, No. 11-2-100/401, Opposite to Government Hospital, Namapally Hyderabad, Andhra Pradesh-500001 (Now Telangana)** vide Order No. F.AP/B.Ed./33/SRO/NCTE/2000-2001/1526 dated 09.08.2000 for conducting B.Ed. Course of one year duration with an annual intake of 160 students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 14.01.2015.

3. **AND WHEREAS**, the SRC in its 285th Meeting held on 17thApril, 2015 has considered the matter and decided that permission is hereby accorded by the SRC to **Anwar-UI-Uloom College of Education, No. 16-14-1/A, New Malakpet, Hyderabad, Andhra Pradesh-500024** to shift its premises to the new location/building at **Anwar Uloom College of Education, No. 11-2-100/401, Opposite to Government Hospital, Namapally Hyderabad, Andhra Pradesh-500001 (Now Telangana)**.


4. **AND WHEREAS**, the Revised Provisional Recognition Order (RPRO) was issued to the institution on 19.05.2015 for conducting **B.Ed. Programme** of two years duration with an annual intake of 150 students (three basic units of 50 students each) from the academic session 2015-16.

5. **AND WHEREAS**, the SRC in its 314th meeting held during 27th& 28thMay, 2016 had considered the reply to the revised order and directed the RD, SRO for initiating VT. As per the decision of SRC, an inspection letter was issued to the institution on 14.06.2016. The inspection was conducted on 06.10.2016 and the Visiting Team Report was received on 13.10.2016.

6. **AND WHEREAS**, the institution has filled the PAR for the academic session 2020-21 in compliance of public notice dt. 29.09.2021 issued by NCTE HQ.

7. **AND WHEREAS**, the SRC in its 413th meeting held on 22nd & 23rdAugust, 2022 took note about the institution who have filled the PAR with certain deficiencies. In view of the above decision, the Regional Committee advised the Regional Director, SRC to issue SCN to all such institution seeking infrastructure and instructional details along with GIS location at the earliest.

Accordingly, as per decision of the SRC Show Cause Notice was issued to the institution on 21.01.2023. The institution has submitted its reply on 14.03.2024.

8. **AND WHEREAS**, the SRC in its 434th meeting held on 22nd March, 2024 considered the matter and decided as under:-

“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Anwarul Uloom College of Education, Survey No. 78, Block D, Namapally, Bazarghat Road, Nampally, Hyderabad- 500001, Telangana for B.Ed. programme for 3 basic units of 50 students each.”

9. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Anwarul Uloom College of Education, H.No. 11-2-400, 401, 816, Survey No. 78, Opposite to Government Hospital, Nampally, Hyderabad-500001, Telangana** for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of **(3 basic units of 50 students each)** subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:



- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it sodesires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
