WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Terasa College of Education, Veerappatti Panchayat, Illupur Taluk, Pudukkottai, Tamilnadu-622102. run by Mother Terasa Educational Charitable Trust, Pudukkottai District, Tamilnadu. vide order no. F.SRO/NCTE/B.Ed./2006-07/13909 dt. 01.11.2007 for conducting B.Ed. course of one years duration with an annual intake of 100 students from the academic session 2006-2007.

- 2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 27.01.2015. The Southern Regional Committee (NCTE) issued the Revised Provisional Recognition Order to the institution on 01.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic unit) from the academic session 2015-2016.
- 3. **AND WHEREAS,** on the basis of request, the SRC in its 343<sup>rd</sup> meeting held on 01<sup>st</sup> 02<sup>nd</sup> July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, an order was issued to the institution on 04.10.2017 reduction of intake from 2 units to 1 unit.
- 4. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> Meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance of RPRO. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 28.08.2019. The institution has submitted a written representation vide letter dt. 04.10.2019 request to close of B.Ed. programme.
- 5. **AND WHEREAS**, the SRC in its 434<sup>th</sup> Meeting held on 22<sup>nd</sup> March, 2024 considered the matter and decided as under: -

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 04.10.2019 by withdrawing the recognition granted to **Terasa College of Education**, **Veerappatti Panchayat**, **Illupur Taluk**, **Pudukkottai**, **Tamilnadu-622102** for conducting **B.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

The FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

6. **NOW THEREFORE,** in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to **Terasa College of Education**, **Veerappatti**

Panchayat, Illupur Taluk, Pudukkottai, Tamilnadu-622102 run by Mother Terasa Educational Charitable Trust, Pudukkottai District, Tamilnadu for conducting B.Ed. course of two years duration with an annual intake of 50 students from the academic session i.e., 2022-2023.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(7. इसके अलावा, संस्था और संबद्घ निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्निलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
