WHEREAS, the recognition was granted to the institution namely St. Agnes College of Education, Plot No 821, Sy No.104, GundlaPonchempally Village, Hakimpet Post Office, Medchal Taluka, Secunderabad City, Ranga Reddy District, Pin:501514, Andhra Pradesh run by Mamta Educational Society, S.No.104, Beside Railway Station, Gundla Pochempally Village, Hakimpet Post Office, Medchal Mandal, Secunderabad Town, Rangareddy District Pin-501514, Andhra Pradesh vide SRC (NCTE) order no. F.No.SRCAPP508/D.EI.Ed/AP/2012/44920 dt. 03.08.2012 for conducting D.EI.Ed. course of one-year duration with an annual intake of 50 students.

AND WHEREAS, on 23.07.2014, a letter dated 17.07.2014 is received by this office from the Mamta Educational Society, 52, Viman Nagar, Secunderabad regarding returning of Original FDRs for renewal purpose. Accordingly, FDRs were sent to institution for renewal on 22.09.2014.

AND WHEREAS, on 17.03.2015 this office has received copy of PROCEEDINGS OF THE DIRECTOR, S.C.E.R.T., T.S., HYDERABAD-1, Rc.No.430/(SCERTAP)/A/TE/ TSCERT/2012 dated 23/02/2015 regarding Verification staff lists for D.Ed course in respect of St. Agnes College of Education, Plot No,821, Sy No.104, Gundla Ponchempally Village, Hakimpet Post Office, Medchal Taluka, Secunderabad City, Ranga Reddy District, Pin:501514, Andhra Pradesh (copy enclosed).

AND WHEREAS, the Southern Regional Committee in its 284th meeting held during 9th to 10th April, 2015 considered the matter, all the relevant documents of the institution, staff list received from SCERT Hyderabad and decided to serve Notice Under NCTE Act for the following deficiencies:-

"Lect (Foundation) &Lect (Science) have crossed age of superannuation"

AND WHEREAS, as per the decision of SRC, a notice was issued to the institution on 06.05.2015. The institution has submitted a reply on 26.05.2015. The SRC in its 290th meeting held on 10th - 11th July, 2015 considered the matter and decided as under:-

Reply to Show Cause Notice not yet received. Remind Resubmit in the 291st meeting.

AND WHEREAS, as per the decision of SRC a letter was issued to the institution on 09.10.2015. The institution vide letter dated 24.12.2019 submitted a written representation. The SRC in its 384th meeting held during 12th to 13th February, 2020 considered the matter and decided as under;

The Committee decided that to withdraw the recognition granted to St. Agnes College of Education, Andhra Pradesh for conducting D.El.Ed. course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 24.12.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

The Committee also decided to FSCN for all the existing other programmes (if any) being run by institution as per the standard 13 points being sought by the SRC, NCTE.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of St. Agnes College of Education, Plot No,821, Sy No.104, Gundla Ponchempally Village, Hakimpet Post Office, Medchal Taluka, Secunderabad City, Ranga Reddy District-501514, Telangana run by Mamta Educational Society, S.No.104, Beside Railway Station, Gundla Pochempally Village, Hakimpet Post Office, Medchal Mandal, Secunderabad Town, Rangareddy District Pin-501514, Telangana for conducting D.El.Ed. programme of one year duration with an annual intake of 50 students (1 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
