ORDER

WHEREAS, the recognition was granted to the institution namely Viveka College of Education, D.No. 6-137, Kothapeta, Vaddesan, Papayaoalayam Post, Chirala, Prakasam District-Andhra Pradesh run by Viveka Educational Society, Prakasam, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/14901 dt. 16.11.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the SRC in its 166th meeting held on 18th and 19th October, 2008. The Committee decided to withdraw the recognition of the institution. As per the decision of SRC a withdrawal of recognition was issued to the institution on 22.10.2008 vide order No. F.SRO/NCTE/Ref/2008-09/6226 for the proposed B.Ed course as per section 15(3)(b) of NCTE ACT.
- 3. AND WHEREAS, aggrieved by the withdrawal order, the institution preferred an appeal to NCTE Hqrs and the <u>Appellate authority of NCTE</u>, <u>New Delhi in its Appeal order dated 19.12.2008 rejected the appeal and the order of SRC was confirmed.</u>
- **4. AND WHEREAS,** aggrieved with the decision of the SRC, NCTE the institution filed a court case and a Court Notice was received by this office on 15.01.2009 from the Hon'ble High Court of Judicature, Andhra Pradesh at Hyderabad in W.P.No.27859 of 2008 dated 23.12.2008 in which NCTE is the 2nd Respondent.
- 5. AND WHEREAS, the Southern Regional Committee considered the case of the institution and finally in its 284th meeting considered the matter, all the relevant documents of the institution, written representation from the institution vide letter dated 09.02.2015, decided as under:
 - 1. Ask the Lawyer to get the 'stay' Vacated.
 - 2. After issue of RPRO get the conformity with the new norms & standards verified through a VT Inspection."
- 6. **AND WHEREAS**, as per the decision of SRC, inspection of the institution was scheduled during 23rd to 25th April, 2015 and the same was intimated to the institution on 20.04.2015. The inspection of the institution was conducted on 26.04.2015 and VT Report was received by this office on 02.05.2015.

- 7. AND WHEREAS, the Southern Regional Committee in its 287th meeting held during 20th May, 2015 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 05.06.2015. On 20.05.2015, an e-mail is received from the advocate. Shri.Ramakanth Reddy which is as under:-
 - "I have been requested to file vacate in the subject cited case. I wish to inform u that the Hon'ble High Court directed the NCTE to consider the representation of the petitioner. As per your letter inspection was conducted after considering the representation dated 09-02-2015. Thereafter provisional recognition was granted. The SRC should consider whether the College fulfills the norms or not. If the college doesn't, then de recognition proceedings should be completed."
 - **8. AND WHEREAS,** on 29.06.2015, the institution has submitted a reply to the show Cause Notice. Thereafter, the matter was placed the SRC in its 294th meeting held on 14, 15 & 16, Nov 2015. The committee considered the matter and decided as under.
 - 1. This is a composite institution offering B.Ed and D.El.Ed.
 - 2. Resubmit along with documents submitted for the second unit of B.Ed.
 - 9. AND WHEREAS, as per the decision taken by the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 a First Show Cause Notice was issued on 06-12-2019 asking the institution to submit all the requisite documents/information to the SRC, NCTE. The institutions vide letter dated nil received on 27.12.2019 & 27.02.2020 submitted reply to the First Show Cause Notice along with documents.
 - **10. AND WHEREAS,** the SRC in its 385th meeting held on 03rd March, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the original documents and records submitted by the institution. The Committee decided that the continuation order be issued to Viveka College of Education, Prakasam District-Andhra Pradesh for B.Ed programme for 2 basic units (50 students each).

11. NOW THEREFORE, this order is issued permitting the institution i.e. Viveka College of Education, Sy.No. 528/2, Vaddesangam, Kothapeta Panchayat, Vetapalem (M), Prakasam District-523157, Andhra Pradesh run by Viveka Educational Society, Vaddesangam, Kothapeta, Vetapalem (M), Chirala, Prakasam District-523157, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-

- 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
