ORDER

WHEREAS, the recognition was granted to the institution namely Pasha Educational Training Institute, 8-2-672, Road No.13, Banjara Hills, Hyderabad-500035, Andhra Pradesh run by Pasha Educational Trust, Hyderabad, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APSO7300/2007-2008/13018/509 dt. 15.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the institution vide letter dated 27.07.2008 requested to change the name of the college from Pasha Educational Training institute to Pasha College of Education.
- 3. AND WHEREAS, the SRC considered the request letter in its 164th meeting held on 20th September, 2008 and permitted the applicant society to change the name of the institution from "Pasha Educational Training Institute" to "Pasha College of Education" & order regarding changing of name is communicated to the institution on 30.09.2008.
- 4. AND WHEREAS, on 27.10.2014 the Principal Pasha College of Education, 8-2-672, Road No.13, Banjara Hills, Hyderabad-500 034, Andhra Pradesh dated 20.10.2014 regarding shifting of campus located at Deenadayal Nagar, Neredmet which comes under Malkajgiri Mandal of Ranga Reddy District.
- 5. AND WHEREAS, the SRC in its 275th meeting held on 1st 2nd December, 2014 considered the matter, request of the institution vide their letter dated 27.10.2014 for shifting of the said institution to their own campus, decided that request for permission to shift can be considered subject to adherence to norms & standards notified in the new Regulations. Institutions may be advised to apply accordingly. Accordingly, a letter seeking consent on the willingness of the institution for considering their application as per Regulations 2014 was sent to the institution on 19.12.2014.
- **6. AND WHEREAS**, in response to this office letter dated 19.12.2014, the institution has submitted a reply on 24.12.2014, along with an affidavit on Rs. 100/- stamp paper expressing their willingness for the application to be processed as per Regulations, 2014. The SRC in its 278th meeting held on 25th January, 2015, considered the matter, Affidavit submitted by the institution vide letter dated 16.01.2015, decided that:-

"Shifting of the institution to new premises is not permitted due to inadequacies of 1. Land Documents

- 2. Building plan not approved.
- 3. BCC not given, etc."
- 7. **AND WHEREAS**, on 25.02.2015, a letter along with all documents dated 20.02.2015 is received by this office from the Correspondent, Pasha Educational Training Institute, Panjagutta, Hyderabad. The SRC in its 283rd meeting held during 02nd& 3rd March, 2015 Considered the matter and decided as under:-
 - BP is not approved by the competent authority.
 - Issue SCN accordingly.
- **8. AND WHEREAS**, in the meantime, on 18.03.2015 before issuance of Show Cause Notice to the institution, on seeing website, the institution submitted a reply to the Show Cause Notice on 18.03.2015. In the meantime on 28.01.2015 a affidavit from the correspondent Pasha Education Training Institute G-5 Pasha Court, Greenlands Road, Panjaguttas Hyderabad Andhra Pradesh received by this office regarding Submitted of Affidavit on the revised norms. SRC in its 284th meeting held during 9th to 10th April, 2015 considered the matter and decided as under:-

"cause inspection"

- **9. AND WHEREAS**, as per the decision of SRC, the inspection of the institution was scheduled during 23rd April to 25th April, 2015 and the same was intimated to the institution on 20.04.2015. The inspection of the institution was conducted on 23.04.2015 and the VT Report was received by this office on 27.04.2015. The SRC in its meeting held on 30th April, 2016 considered the matter and decided as under:
 - Permit shifting of premises for B.Ed.
- 10. AND WHEREAS, the institution shifting order of new premises <u>Pasha Educational</u> <u>Training Institute</u>, No. 29-1380/4, 29-1380/4/4, <u>Deendyal Nagar</u>, <u>Neredmet</u>, <u>Hyderabad-500056</u>, <u>Andhra Pradesh</u> and revised order was issued to the institution on 13.05.2015 for 150 students of three basic units.
- 11. AND WHEREAS, the inspection intimation was sent to the institution on 14.06.2016. The institution has submitted inspection fees of Rs. 1,50,000/- on 16.07.2016. The name of VT members were generated through online. The inspection was conducted on 07.10.2016 and the VT report along with documents and CD received on 18.10.2016. The SRC in its 348th meeting held during 05th & 06th December, 2017 Considered the matter and decided as under:-
 - 1. Title is clear in favour of Pasha Edl. Trg Institute. Land area of 2641Sq mts is adequate for B.Ed (2 units).
 - 2. LUC not given. Ask them to give.
 - 3. EC is in order.
 - 4. BP is in order. Built up area shown is 2191 sqmts.
 - 5. BCC is in order. Built up area shown of 2191 sq mts is adequate for B.Ed. (2 units).

- 6. FDRs are in order.
- 7. Faculty list is not approved by competent authority. It should be approved and authenticated on every page by the Registrar of the affiliating University.
- 8. Issue SCN accordingly
- 12. AND WHEREAS, as per decision of SRC Show cause notice was issued to the institution on 12.12.2017. The institution submitted its written representation along with documents on 16.01.2018. The SRC in its 360th meeting held during 23rd& 24th May, 2018 considered the matter and decided as under;
 - 1. This is a RPRO case of B.Ed (2 units).
 - 2. LUC is still not given. Even Urban areas have Master Plans segregating areas for different purposes like Residential, Commercial, Industrial, etc. The Municipal Commissioner will ordinarily give this certification and approve the BP.
 - 3.1 Faculty list is given. We need a list of 1 +15. They have given a list of 1 +15.
 - 3.2 Principal, appointed in 2002, is qualified.
 - 3.3 They have not shown the Faculty GroupWise. Although they have the total number of 1 + 15, in the absence of GroupWise segregation, it is not possible to conclude where the excess is and where is the shortage. They should clarify.
 - 3.4 One Asst. Prof (FA) is required.
 - 4. Issue SCN accordingly.
- 13. AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 31.05.2018. The institution did not reply to the show cause notice till date. The matter was further considered by the Sub-Committee constituted by the SRC as per decision taken in its 380th meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the Institution.
- 14. AND WHEREAS, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 11.10.2019. The SRC in its 383rd meeting held during 26th 27th November, 2019 considered the case and decided to withdraw the recognition. However since the reply of the institution was received by this office, the matter was further considered by the SRC in its 383rd meeting of SRC held during 07th to 09th January, 2020 for confirmation. The matter was considered by SRC and decided as under;

The Committee noted that the institution has earlier submitted its reply vide letter dated 16.11.2019 which need to be considered by the SRC. The matter be placed in the next meeting with detailed agenda note.

15. AND WHEREAS, the institution vide letter dated 16.11.2019, 30.11.2019 & 03.02.2020 submitted a written representation along with the documents. The institution vide letter dated 16.11.2019 submitted that the documents pertaining to the institution building had already submitted to your office.

16. AND WHEREAS, the matter of the institution was finally considered by the SRC in its 385th meeting held on 03rd March, 2020 and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records submitted by the institution. The Committee decided that the continuation order be issued to Pasha College of Education, Hyderabad, Telangana for B.Ed programme for 2 basic units (50 students each).

- 17. NOW THEREFORE, this order is issued permitting the institution i.e. Pasha College of Education, No. 29-1380/4, 29-1380/4/1, Deendyal Nagar, Neredmet, Hyderabad-500056, Telangana run by Pasha Educational Trust, Hyderabad, Telangana for continuation of recognition for B.Ed course of two years duration with an intake of (two units) of 50 students each subject to fulfillment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **18.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 19. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 20. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and

laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students:
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 21. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 22. The institution shall make available the list of students admitted on its official website.
- 23. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
