WHEREAS, the recognition was granted to the institution namely Kanara Welfare Trust's B.Ed College, Janatha Vidhyalaya Campus, Dandeli-581325, Uttarakannada, Karnataka run by Kanara Welfare Trust, Ankola, Uttara Kannada-581314 Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/ASP03710/B.Ed/2005-2006/4785 dt.21.12.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the matter regarding the institution was considered by the SRC in its 314th meeting held during 27th and 28th May, 2016 and in its 341st meeting held during 15th 16th June, 2017 considered the request of the institution and decided to issue show cause notice. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 06.07.2017. The institution has submitted show cause notice reply on 12.09.2017.
- **4. AND WHEREAS**, the SRC in its 362nd meeting held during 21st -22nd August, 2018 considered the request of the institution and decided to issue letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 07:09.2018. The institution did not submitted reply and the matter was considered by the SRC in its 371th meeting held from 25th & 26th February, 2019 and the Committee decided to issue withdrawal order.
- 5. AND WHEREAS, the SRC withdrawal order no. F.SRO/NCTE/APSO3710 /B.Ed/KA/2019/101962-968 dated 06.03.2016 was issued to the institution.
- 6. AND WHEREAS, aggrieved by the withdrawal order, the institution preferred an appeal to NCTE-Hqrs. The Appellate Authority in its order vide letter no. F.No. 89-195/E-117991/2019. Appeal/17th Mtg.2019/12th June, 2019 dated 05.07.2019 the Council hereby confirms the Orders appealed/against. on the request of the institution made vide letter dt. 27.12.2019 the following may be clarified. The SRC vide letter no. F.SRC/NCTE/APSO3710/113405 dated 06.01.2020 was issued to the institution.
- 7. AND WHEREAS, aggrieved by the order of the Council, the institution filed a Writ Petition No. 112306/2018 before the Hon'ble High Court of Karnataka, Dharwad Bench. And the matter was against considered the Council. The Appellate Authority vide order no. F.No. 91-

On the perusal of the reply submitted by the institution vide letter dt. 13.03.2020, Committee decided that the continuation order be issued to the Institution Kanara Welfare Trust's B.Ed College, Uttarakannada, Karnataka for B.Ed programme for 1

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Kanara Welfare Trust's B.Ed College, Ward No. 21, Barchi Road, Dandeli City Municipal Council, Dandeli-581325, Uttara kannada, Karnataka run by Kanara Welfare Trust, Ankola, Uttara Kannada-intake of 50 students (1 basic unit) of subject to fulfillment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office,
