WITHDRAWAL ORDER**

AND WHEREAS, the recognition was granted to the institution namely, Mangalam College of Education, Ettumanoor, Kottayam-686631, Kerala run by Mangalam Foundation Charitable Society, Mangalam Building, SH Mount, Kottayam-686006, Kerala vide SRC (NCTE) order No. F.KL/Sec/27/SRO/NCTE/2000-2001/8426 dated 01.11.2001 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations.

3. AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.

4. AND WHEREAS, the institution submitted written representation dated 27.06.2016 & 14.12.2016 requesting therein for reduction of strength from 2 units to 1 unit in its B.Ed. course.

5. AND WHEREAS, the request of the institution was placed before SRC in its 343<sup>rd</sup> meeting held on August 1-2, 2017 and the committee considered the matter and decided to issue order for the reduction of strength and resubmit the case for RPRO processing. Accordingly, order for reduction of strength issued to the institution on 28.09.2017.

6. AND WHEREAS, The matter was further considered by the SRC in its 383<sup>rd</sup> meeting held on 7<sup>th</sup> -9<sup>th</sup> January 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Institution was issued a Show Cause Notice (SCN) on 17.07.2019. The institution has not submitted any reply / written representation against the Show Cause Notice issued. Hence, the Committee decided to issue Final Show Cause Notice for B.Ed & M.Ed courses to the institution to submit the following documents :-

1. The institution has not submitted original blueprints of Building Plan. The multipurpose hall, date of approval, approving authority & earmarking for each course (if running 2 or more courses) not reflecting. Built Up area not mentioned.
2. The institution has submitted faculty which is not in prescribed format. Also date of appointment not mentioned for each faculty. The affiliating university's letter submitted but date & seal of the registrar not mentioned.
3. The LUC submitted by the institution is in the individual name i.e. Sri MC Varghese s/o Chacko (President of Mangalam Foundation).
4. BCC- Not Submitted

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

7. **AND WHEREAS**, as per decision taken in the meeting 383<sup>rd</sup>, a Final Show Cause was issued to the institution on 20.01.2020. In response, the institution submitted its reply on 17.02.2020.

8. **AND WHEREAS**, the matter was further considered by the SRC in its 388<sup>th</sup> meeting held on September 14-15, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*On the perusal of the reply submitted by the institution on 12.02.2020. The Committee observed and found the following deficiencies: -*

1. *Building plan submitted by the institution is not approved by the competent authority. In Building plan, Survey No & site are not mentioned.*
2. *The BCC submitted by the institution is not approved by the competent authority.*
3. *The institution has not appointed faculty for Fine Arts.*

Hence, the Committee decided to withdraw the recognition granted to Mangalam College of Education, Ettumanoor, Kottayam-686631, Kerala for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

9. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Mangalam

College of Education, Ettumanoor, Kottayam-686631, Kerala for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.

10. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

11. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
