WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **G.B.R. College of Education, East Godavari District, Andhra Pradesh** vide SRC (NCTE) order no. F.AP/NEW/B.Ed/173/SRO/NCTE/2002-2003/6120 dt 28.02.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 17.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the institution submitted written representation on **28.10.2015** requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. The SRC issued a Corrigendum vide Order No.F.SRO/NCTE/APS0256/B.Ed/AP/2015/ 77384 to the institution on 30.10.2015 reduction intake of 2 units to 1 unit.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice issued to the institution on 06.03.2019. The institution vide letter dated 01.04.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 13.11.2019. The institution submitted its reply to the final show cause notice along with documents vide letter dated 30.11.2019.

AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noticed that the institutions which were granted recognition on Rented Premises with a condition to shift its building to new permanent building. And, the institutions which have not yet shifted to its own permanent building.

1. The institution has not shifted its institution to own permanent building which is a violation of the NCTE Regulations 2002, 3(c).

In view of the above, the institution also not replied to remove the following deficiencies:

2. The institution has also not submitted an application for shifting of premise from rented to owned as required under NCTE Regulations.
3. As per the recognition order No. F.AP/NEW/B.Ed/173/SRO/NCTE/2002-2003/6120 dated 28.02.2003.
4. The institution shall shift to its own premises within three year from the date of recognition (In case the course is started in rented)
5. As per VT report at the time of recognition nature of possession of land was on lease
6. The institution has not submitted certified copy of Registered Land documents.
7. The institution has submitted notarize copy of building plan but building details not readable.
8. The institution has submitted notarize copy of site plan but survey No. and total area not mentioned.
9. The institution has submitted notarize copy of Building Completion Certificate but multipurpose hall not mentioned.

Hence, the Committee decided to **Withdraw the recognition** granted to **GBR College of Education, Rajahmundry Revenue Division, East Godavari District- 533342, Andhra Pradesh** for conducting **B.Ed.** course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **G.B.R. College of Education, East Godavari District, Andhra Pradesh** for conducting **B.Ed.** programme of two year duration with an annual intake of **50** students (1 unit) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a

course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.


