WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **AVM Institute of Elementary Teacher Education, Adarsha Nagar, Mossi Road, Post Office and Mandal, Nakrekal, Nalgonda District, Andhra Pradesh** run by **AVM Educational Society, Adarsha Bhavan, Musi Road, Road No. 1, Nakrekal, Nalgonda District, Andhra Pradesh** vide SRC (NCTE) order No. F.No.APS02828/D.Ed/AP/2012/46288 dated 18.09.2012 for conducting **D. Ed course** of two-year duration with an annual intake of 50 students.

AND WHEREAS, the institution vide letter dated 31.08.2020 submitted written representation. The SRC in its 388th meeting held during 14th - 15th September, 2020 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to **withdraw the recognition** granted to **AVM Institute of Elementary Teacher Education, Adarsha Nagar, Mossi Road, Post Office and Mandal, Nakrekal, Nalgonda District, Telangana** for conducting **D.Ed course** under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 31.08.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- NOC from the affiliating body.
- NOC from the staff/faculty.
- Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **AVM Institute of Elementary Teacher Education, Adarsha Nagar, Mossi Road, Post Office and Mandal, Nakrekal, Nalgonda District, Telangana** for conducting **D.Ed programme** of two years duration with an annual intake of 50 students (1 unit) from the next academic session starts after issuance of this order.


Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day

fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
