#### **ORDER**

WHEREAS, the institution namely Annai College of Master of Education, Salem Main Road, Nambipatty Village, Doddampatty Post, Pappireddipatty Taluk, Dharmapuri District, Tamilnadu-636903 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/8998 dt. 08.11.2006 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the institution namely Annai College of Master of Education, Nambipatti Village, H. Doddampatti Post, Pappireddapatti Taluk, Dharmapuri District, Tamilnadu-636903 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed./2008/5128 dt. 22.09.2008 for conducting M.Ed. course of one-year duration with an annual intake of 25 students.
- 3. AND WHEREAS, the Tamilnadu Teachers Education University had forwarded a copy of show cause notice issued to the institution for not functioning in accordance with the conditions stipulated by the NCTE, SRC, Bangalore and Tamilnadu Teachers Education University as could be apprehended from the report of Inspection commission which caused a surprise visit to the colleges.
- 3. AND WHEREAS, the consequent upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 vide SRC, NCTE order dt. 25.08.2010.
- 4. AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution dt. 20.01.2015 the provisional revised recognition order was issued to the institution on dt. 30.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two units)** from the academic session 2015-16 and in respect of M.Ed. course affidavits submitted dt. 20.01.2015 by the institution, the provisional revised recognition order was issued to the institution on 22.05.2015 for conducting **M.Ed. course of two years duration with an annual intake of 50 (one unit)** from the academic session 2015-16.

- 5. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice was issued to the institution on 06.09.2019.
- 6. AND WHEREAS, the institution submitted its reply along with documents on dt. 01.10.2019 and dt. 31.01.2010. Now, the matter was placed before the SRC in its 386<sup>th</sup> meeting held on 23<sup>rd</sup> 24<sup>th</sup> July, 2020 considered and decided as the following grounds:

"The Committee considered the Show Cause Notice's reply submitted by the institution on 01.10.2010 & 31.01.2020 and found the following deficiencies: -

- 1. The institute did not submit originally certifies copy of Land documents.
- 2. The institute did not submit notarized English translation of NEC.
- 3. The LUC is not on the letter head of issuing authority.
- 4. The institute did not submit notarized copy of LUC. Further as per NEC the nature of land is Agricultural, hence, the LUC cannot be accepted.
- 5. The nature of land is agricultural and notarized English translation of NEC not submitted.
- 6. The institute did not submit the details of managing trust/society.
- 7. The institute did not submit the details of website.
- 8. Faculty namely Jayasankar S. in B.Ed. is not qualified as per NCTE Regulations, 2014.
- The English translation of Sale deeds submitted in M.Ed. and B.Ed. course mentions the different name of owner as "Anna Educational Trust" and "Annai Educational Trust" respectively.
- 10. Faculty for M.Ed. course have not been approved by the affiliating body.
- 7. AND WHEREAS, the Committee decided to issue **Final Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of **Final Show Cause Notice.**" Accordingly, a Final Show Cause Notice was issued to the institute vide dated 24.08.2020. The institution was submitted its reply along with documents vide dated 05.09.2020.
- 8. AND WHEREAS, the matter was placed before the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> 15<sup>th</sup> September, 2020 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution vide letter dt 05.09.2020, the Committee decided that the continuation order be issued to the Institution Annai College of Education, Dharmapuri District, Tamilnadu-636903 for following existing courses:-

- (i) B.Ed. 2 units (50 students each unit).
- (ii) M.Ed. 1 unit of 50 students."
- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Annai College of Education, 101/3A, 3B, 102/1C,2, 107/1A1, 1B2, 1B2A, 4B & 111/4G Nambipatti Village, H.Doddampatti Post, Pappireddipatti Taluk, Harur, Dharmapuri District-636903, Tamilnadu for continuation of recognition for M.Ed. course programme for 1 unit of 50 students subject to fulfilment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 11. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - i. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
