#### Withdrawal Order

WHEREAS, the institution Annai Mathammal Sheela College of Education, Erumapathy Post, Namakkal – 637021, Tamil Nadu was granted recognition on dated 01.06.2009 for conducting M.Ed. course of one year' duration with an annual intake of 25 students. The enhancement of intake from existing 25 to 35 was permitted on 20.08.2010.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 23.01.2015 for its willingness of one basic unit in **M.Ed.** course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 25.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 students from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued on 13.07.2019. The institution has submitted its reply on 22.04.2019. The institution has submitted following documents:

#### Note: -

It is pertinent to mention that the matter of B.Ed. course of the institution was placed before the SRC in its 383<sup>rd</sup> meeting held on 07<sup>th</sup> to 09<sup>th</sup> January 2020. The committee considered the matter and decided as under: -

"The Management of the institution had not submitted required documents in response to letter issued to the institution on 03.08.2016. Another opportunity

was given to the institution by serving a Final Show Cause Notice dt. 21.11.2019. The institution did not submit its reply/representation in response to final show cause notice.

Hence, the Committee decided to withdraw the recognition granted to the institution for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

AND WHEREAS, a withdrawal order was issued to the institution in B.Ed course on 21.01.2020. Accordingly, the Committee may please decide the matter of M.Ed course as it can not run alone.

AND WHEREAS, the SRC in its 388th meeting held on 14th & 15th September 2020 and considered the matter as under:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The recognition of B.Ed. course being run by the institution has been withdrawn on the grounds that the Management of the institution had not submitted required documents in response to letter issued to the institution on 03.08.2016. Another opportunity was given to the institution by serving a Final Show Cause Notice dt. 21.11.2019. The main discrepancies in B.Ed. course, observed by the SRC is as under:-

- 1. The BCC submitted by the institution is not in format as prescribed by NCTE.
- 2. The institution has submitted photocopy of Building Plan which is not approved by the competent authority. The Survey No, Plot Area are not mentioned in the building plan. The size of the multipurpose hall is not adequate as per NCTE Regulations, 2014.
- 3. The LUC submitted by the institution wherein the Land was converted from "Agricultural Land to Non-Agricultural Land"

- 4. The institution has not submitted Form A towards creating Endowment and Reserve fund as per NCTE Regulations, 2014.
- 5. The institution has submitted approval letter duly approved by the Registrar, TNTEU wherein the faculty namely A. Balakumar, Mrs. P. Kalaibhavani, V. Manikandan, Mrs. C. Manimekala, Mrs. M. Veeramani, Mrs. G. Kamala are not having NET/SET as per NCTE Regulations Notification dt 09.07.2017

AND WHEREAS, a withdrawal order was issued to the institution in B.Ed course on 21.01.2020.

AND WHEREAS, the SRC decides to withdraw the recognition granted to AnnaiMathammal Sheela College of Education, Erumapathy Post, Namakkal – 637021, Tamil Nadu for conducting M.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993as the institution can't run M.Ed. course without B.Ed. recognition and it will be a stand-alone one also.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a>, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
