WHEREAS, the recognition was granted to the institution namely St. Mary's Shikshana Maha Vidhyalaya, Kote Road, K.B. Extension, Chitradurga-577501, Karnataka vide SRC (NCTE) order No F.SRO/NCTE/B.Ed/2004-2005/8845 dated 30.11.2004 for Secondary B.Ed. Course of one-year duration with an annual intake of 100 students.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 27.11.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 decided to issue Show Cause Notice to all such institution where compliance /representation has not been submitted by the institution. Accordingly, as per the decision of SRC a first show cause notice was issued to the institution on 08.11.2019. The institution vide letter dated 29.11.2019 has submitted reply to the Show Cause Notice.

4. AND WHEREAS, The SRC in its 400th meeting held on 13th-14th July 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 29.07.2021. The institution vide letter dated 04.08.2021 has submitted reply to the Final Show Cause Notice.

5. AND WHEREAS, the SRC in its 403rd Meeting held on 18th -19th October, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 04.08.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted photocopy of Lease Deed in which survey no. is not mentioned.
- 2. The institution has submitted photocopy of Land Use Certificate which is stamped in regional language and survey no. is not mentioned.

- 3. The institution has submitted photocopy of Building Plan, which is not approved. Survey no. and site area are not mentioned and, area of multipurpose hall is not legible in it.
- 4. The institution has not submitted latest faculty list along with approving letter issued by the affiliating body.
- 5. The institution has still not submitted Form "A" issued by the Branch Manager with the photocopy of two FDRs in favor of NCTE.
- 6. The institution has not submitted an affidavit clearly stating status about land, building and management (Society/Trust) at the time of recognition.
- 7. The website of the institution is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to St. Mary's Shikshana Maha Vidhyalaya, Kote Road, K.B. Extension, Chitradurga-577501, Karnataka for conducting B.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

6. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of St. Mary's Shikshana Maha Vidhyalaya, Kote Road, K.B. Extension, Chitradurga-577501, Karnataka for conducting B.Ed. programme of two year duration with an annual intake of 100 students (two basic units) for B.Ed. course with effect from the academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <u>www.ncte-india.org</u> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
