WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **Visveswaraya B.Ed College, New Bridge Road, Siddarudanagara Old Town, Bhadravathi-577301, Karnataka** run by **Visveswaraya Educational Society, (R), New Bridge Road, Old Town, Bhadravathi, Bhadravathi, Karnataka** vide SRC vide order no. F.SRC/NCTE/2009/B.Ed./RO/1188 dt. 24.04.2009 for Secondary (**B.Ed.**) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 29.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 15.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students for two basic units** from the academic session 2015-16.

3. **AND WHEREAS**, the institution submitted written representation on **10.06.2015** requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. A corrigendum vide order no. F.No.SRO/NCTE/APS08294/B.Ed./KA/2015-2016/69064 dated 01.07.2015 was issued to the institution permitting the institution to have **one basic unit of 50 students** from the academic session 2015-2016.

4. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 08.05.2019. The institution has submitted reply on 31.05.2019.

5. **AND WHEREAS**, the SRC in its 399th meeting held on 15th – 16th June, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final show cause notice was issued to the institution on 29.06.2021. The institution has submitted reply on 25.08.2021.

6. **AND WHEREAS**, the SRC in its 403rd Meeting held on 18th & 19th October, 2021 considered the FSCN reply matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice. The institution has submitted its reply on 25.08.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution has submitted notarized copy of faculty approved by Registrar Kuvempu University vide dated 27/07.

(i) 07 Assistant Professor does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.

2. The institution has submitted translated photocopy of land documents instead of notarized/certified.

3. The institution has submitted notarized copy of Non-Encumbrance Certificate in which Survey No. is not mentioned.

4. The institution has submitted Building Plan in which total built-up area and Multipurpose Hall area not sufficient as per NCTE Regulation 2014.

*Hence, the Committee decided to **withdraw the recognition** granted to **Visveswaraya B.Ed. College, New Bridge Road, Siddarudanagara Old Town, Bhadravathi-577301, Karnataka** for conducting **B.Ed. programme** with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Visveswaraya B.Ed. College, New Bridge Road, Siddarudanagara Old Town, Bhadravathi-577301, Karnataka** run by **Visveswaraya Educational Society, (R), New Bridge Road, Old Town, Bhadravathi, Bhadravathi, Karnataka** for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2021-2022 onwards.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition

or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
