WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **Dr. C L Naidu College of Education, Palakonda Revenue Division Palakonda, Srikakulam District, Andhra Pradesh-532440** vide order no. F.AP/NEW/B.Ed./241/SRO/NCTE/2002-2003/6658 dt. 08.04.2003 for conducting **B.Ed.** course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 10.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students for two basic units** from the academic session 2015-16.

3. **AND WHEREAS**, a Corrigendum was issued to the institution vide order no. F.SRO/NCTE/APS00308/B.Ed./AP/2015-16/70181 dt. 17.07.2015 with an annual intake of 50 students for one basic unit.

4. **AND WHEREAS**, the institution has submitted a request dated 12.04.2018 regarding closure of the B.Ed. Course from the academic session 2017-2019 and 2018-2020.

5. **AND WHEREAS**, the SRC in its 406th Meeting held on 19th January, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*The Committee agreed to close down the institution as requested by the institution vide dated 12.04.2018 by withdrawing the recognition granted to **Dr. C.L. Naidu College of Education, Palakonda-532440, Srikakulam District, Andhra Pradesh** for conducting **B.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.*

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Dr. C.L. Naidu College of Education, Palakonda-532440, Srikakulam District, Andhra Pradesh** run by **Sri Kota Durga Educational Society, Palakonda-532440, Srikakulam District, Andhra**

Pradesh for conducting B.Ed. programme of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2021-2022 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
