WHEREAS, the recognition was granted to the institution namely, Ashraya D.Ed. College, Hasagal Road, Mudigere, Chikmagalur District, Karnataka-577132 run by Ashraya Samajika Seva Samsthe, Mudigere, Chikmagalur District, Karnataka vide order no. F.SRO/NCTE/D.Ed/2004-2005/9149 dt. 03.12.2004 for conducting Elementary (D.Ed.) course of two and half year's duration from the academic session 2004-05 with an annual intake of 50 students.

- AND WHEREAS, a letter dated 17.12.2021 received from Member of Parliament, Leader of Opposition, Rajya Sabha for closure of the D.Ed. course.
- AND WHEREAS, the SRC in its 406th Meeting held on 19th January, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution has submitted request letter on 13.01.2018 by withdrawing the recognition granted to Ashraya D.Ed. College, Hasagal Road, Mudigere-577132, Chikmagalur District, Karnataka for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Ashraya D.Ed. College, Hasagal Road, Mudigere-577132, Chikmagalur District, Karnataka run by Ashraya Samajika Seva Samsthe, Mudigere, Chikmagalur District. Karnataka for conducting D.Ed. programme of two and half year's duration with an annual intake of 50 students with effect from the academic session i.e., 2022-2023 onwards.

**5.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

**6.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
