WITHDRAWAL ORDER

WHEREAS the institution namely Dr. C.R.R. D.Ed. College, No. 467,469-1, Plot No. 677, 8th Street, Sydapuram Village & Post, Gudur Taluk, Nellore District, Andhra Pradesh-524407 run by Annapoorna Educational Society, No. 677, College Road, Sydapuram Village & Post, Gudur Taluk, Nellore District, Andhra Pradesh-524407 granted recognition vide SRC (NCTE) order no. F.No.SRCAPP1627/D.El.Ed./AP/2012/45892 dated 05.09.2012 for conducting D.El.Ed. course of two years duration with an annual intake of 50 students (1 unit) from the academic sessions 2012-2013.

AND WHEREAS, the matter of the institution was placed before the SRC in its 386th Meeting held on 23rd & 24th July 2020. The Committee considered the matter and decided to issue a Show Cause Notice to the institution to submit the compliance. Accordingly, a Show Cause Notice was issued to the institution on dt. 14.08.2020.

AND WHEREAS, the institution vide letter dt. 02.02.2021 requested for closure its D.EI.Ed course from the academic session 2020-2021.

AND WHEREAS, the SRC in its 395th Meeting held on 25th & 26th February 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the management by its letter dt 20.02.2021 by withdrawing the recognition granted to **Dr. C.R.R. D.Ed College, No. 467, 469-1, Plot No. 677, 8th Street, Sydapuram Village & Post, Gudur Taluk, Nellore district 524407, Andhra Pradesh for conducting D.El.Ed course** under clause 17(1) of NCTE Act, 1993 from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Dr. C.R.R. D.Ed College, No. 467, 469-1, Plot No. 677, 8th Street, Sydapuram Village & Post, Gudur Taluk, Nellore district 524407, Andhra Pradesh run by Annapoorna Educational Society, No. 677, College Road, Sydapuram Village & Post, Gudur Taluk, Nellore District, Andhra Pradesh-524407 for conducting D.EI.Ed. course of two years duration with an annual intake of 50 students (one unit) with effect from the next academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
